IV. Knowledge Share: Serving Victims of Crimes - Guest Speakers: - Juanita Rogers/Kathryn

• Debbie Feinstein, Esq, Senior Assistant State's Attorney & Chief, Special Victims Division:

More support to be able to help victim coordinators who work extraordinary hours. Victim coordinators do a lot of training with staff on trauma informed approach and can always use more. Collaboration between agencies within the County is very important when helping victims.

- Sergeant Jason Bahm Sexual Assault Unit family outreach section. Has been a police officer for twenty-eight years. Helping people to scape situations that seemed impossible to escape makes a difference. He Works closely with VASAP Victim Assistance and Sexual Assault Program. There is a gap that needs to be filled is the need to provide "Hope Phones" to victims of sexual assault. The Family Justice Center has phones but those are for the domestic violence unit.
- Nurse Vania Baioni, from the Forensic Medical Unit of Adventist Shady Grove Medical Center

Vania has been working on the Forensic unit since 2015, she has had a great experience. She has noticed an increase in victims for domestic violence since the pandemic, strangulation is the most common for domestic violence.

• Jodi Finkelstein, Human Trafficking Prevention Committee of the Commission for Women

Serves as a connector and find the gaps and work towards prevention of future gaps. Follows policy legislation that protects survivors of human trafficking.

• Ashley Noy, Client Assistance Specialist Assistant Client Specialist for domestic violence cases at the Family Justice Center. Clients that may come to the unit feel safe. There are amenities such as toys for children in a designated area, a kitchen. Etc. The Family Justice center serves females and males. Their staff is bilingual (English and Spanish). The Family Justice Center needs more funding to be able to help more victims because of the case load being so high.
