## Dear Prospective Applicant:

Maryland Family Network, Inc. (MFN), on behalf of its public and private funders, solicits proposals from public and private nonprofit organizations to develop and operate a Family Support Center in Montgomery County, Maryland. Maryland Family Network will fund one lead agency through a competitive Request for Proposals process.

Family Support Centers are community-based programs where expectant women and parents – mothers and fathers – with children birth through age three come together to experience a hospitable and constructive environment that provides or links to those services necessary to support and strengthen families as functioning units. The Centers operate one program for two generations and provide services that promote nurturing and competent parenting, physical and mental health of parents and children, family economic independence, and full growth and development of young children.

Successful applicants will need to secure a facility of at least 4,000 square feet accessible to prospective participants (in a neighborhood setting) with access to usable outdoor space for very young children. At least 1,000 contiguous square feet of this space should be designated for the child development program.
