- Brittany Freeman discussed working with Riderwood TV Club on future programs. For
 programs, there is potential to partner with a group or committee at Riderwood to do a
 speaking engagement or educational video. The Committee will keep this in mind for
 future outreach.

OFFICE REPORT

- Patty Vitale provided an OCP office update:
 - OCP is looking to hire a new Investigator with a focus on new home construction, as well as bringing on 2 summer interns.

 OCP submitted a change to the County towing regulations to increase the fees that towers can charge. An OCP Investigator did an evaluation on this. The Council has set it for a hearing.
