MISSION STATEMENT

The mission of the Office of Legislative Oversight is to determine the effectiveness of legislation enacted by the County Council, and to make findings and recommendations concerning the performance, management, and operation of programs and functions for which funds are appropriated or approved by the Council.

BUDGET OVERVIEW

The total approved FY11 Operating Budget for the Office of Legislative Oversight is \$1,246,420, a decrease of \$94,650 or 7.1 percent from the FY10 Approved Budget of \$1,341,070. Personnel Costs comprise 95.7 percent of the budget for eight full-time positions and three part-time positions for 9.1 workyears. Operating Expenses account for the remaining 4.3 percent of the FY11 budget.

OLO studies the effectiveness of legislation enacted by the Council and makes findings and recommendations concerning the performance, management, and operation of programs and functions for which funds are approved or appropriated by the Council. OLO is also the designated administrator for the Council's audit contracts, as required under Section 315 of the County Charter.
