## ORDER IN RESPONSE TO NOVEMBER 19, 2024 FOLLOW-UP SHOW CAUSE HEARING

Pursuant to the Show Cause Order dated November 26, 2025, the Hearing Examiner held an on-site hearing on December 5, 2025, 2024 to familiarize herself with the subject property. The property is located on Garrett Road in Derwood, Maryland. The property address at the time of the application was 7009 Derwood Road, and the development was described as "Cashell Estates" in Preliminary Plan No. 120160210.

In attendance were Mr. Dean Packard, the applicant for the conditional use, Mr. Greg Nichols, the Montgomery County Department of Permitting Services, and Cashell Estates residents Nicole Soltyka, Patti Simone, Justin Hughs, and Robbie Chan. At the beginning of the hearing, the Hearing Examiner instructed that they should not ask the Hearing Examiner questions. She informed them that the Hearing Examiner will place her observations on record at the next remote hearing, and that they may comment on them at that time. Mr. Packard and Mr. Nichols identified various improvements required by the conditional use site plan that remain to be completed. These shall be identified more particularly on the record at the next remote show cause hearing, when the Hearing Examiner summarizes her observations of the site.
