Again today, I was discriminated against, harassed and bullied by Marian Altman, James Olsen, Jonas Weiss and Phil Marks when I attended the Leisure World Foundation meeting this morning.

Starting at approximately 9:33 AM, the following was spoken:

Marian Altman ("Altman") : "you cannot use your computer", "no computer".
Sheryl Katzman ("slk") : "You received a request for reasonable accommodation, did you not?"
Altman: "I want to see a note from a doctor".

slk: "That's beyond the scope of the law"

Altman: **"I don't care, no computer."**

slk: You received the request and you're aware of harassment under the Fair Housing Act, right?"

Altman: **"yeah"**

slk: "Well you're in violation of that"

Altman: **"Well, you tell me what disability you have" .**

slk: "You know that's a violation of law to even make that request."

Altman: **"No computer. No computer".**

slk: "I need my computer because I can't write any notes at length. That is the whole reason for the computer."

Altman: **"I said no computer".**

slk: "Well, sorry Marian."

Altman: **"Then you can leave"**

slk: "I'm not leaving either"

Jonas Weiss: **"call security" -**

Susanne Offit: **"no come on- don't be like United Airlines" .**

James Olsen: **"I move that the meeting be closed"**

slk: "I think you have to have a valid reason under the Md. HOA Act to close a meeting"

Phil Marks: **"We are not part of the homeowners association"**

slk: "but you are because you're on LWCC property"

Phil Marks: **"When you cite the opinion and give it to us in writing--"**

slk: "I think you'll get it from the authorities - not me"

Phil Marks: **"you're not an authority"**

slk: "no, I am not"

Altman: **"Sheryl, you can leave"**

Suzanne Offit: **"Tender justice with mercy"**

Marian Altman instructs Leisure World of Maryland Administrative Assistant Ellen Solomon to call security -

Of interest - while waiting for the officer(s) to arrive - (non-related to me or my disability), LW Foundation Director Billie Saunders identified that she is having shoulder surgery which will incapacitate use of her writing hand. Foundation members were discussing how the use of one just one hand "inconveniences" a person.

Moments later, a LW Security officer named "Victor" responded - I met him at the meeting room entry and we walked down the hallway together. I explained that I had attended this and last month's Leisure World Foundation meeting, and that although my disability and need to use my laptop had been clearly identified, Marian Altman denied me right to use my computer. Moments later, another security guard "Mr. Bernal" responded. He was informed that Marian Altman called security after denying use of my laptop in the meeting and telling me to leave. He said: "I'm sorry for the inconvenience" and "what we're going to do is write a statement - a small report".
