Good Morning Lenny and thank you for reaching out.

As part of an effort to help remediate any sounds or noise that may come from our property, we are building a dirt berm between our properties at the recommendation of the County. The berm will reside solely on our property and will conform to county code and guidelines.

The dirt that has been placed so far should be on our property even though some of it is on the crops that have even planted by Pleasant Valley Farm and shown in your picture. We asked our contractor to make sure it all stayed on our property and hopefully that is what has happened. We will work to have the property line more clearly marked so everyone will be able to differentiate between the real property line and current crop planting line going forward. We believe the crops have been planted on our property for years but since it wasn't impacting us we just let it go. We will be happy to share the tax and property maps we are working form once we have everything marked so you can verify it independently. We are building the berm for your benefit and we want you and all our neighbors to be happy with our efforts and clear on them.

We apologize for any confusion this may have caused and we will be happy to remove any dirt that may have fallen across the property line accidentally once we get it marked.
