- At Warner Memorial Presbyterian Church, a 72 kW solar project not only offsets the church's electricity use but also supports Housing Unlimited, a local nonprofit dedicated to affordable housing. Through the strategic allocation of community solar credits, Housing Unlimited saves up to \$1,400 annually, strengthening its mission while contributing to the County's sustainability goals.
