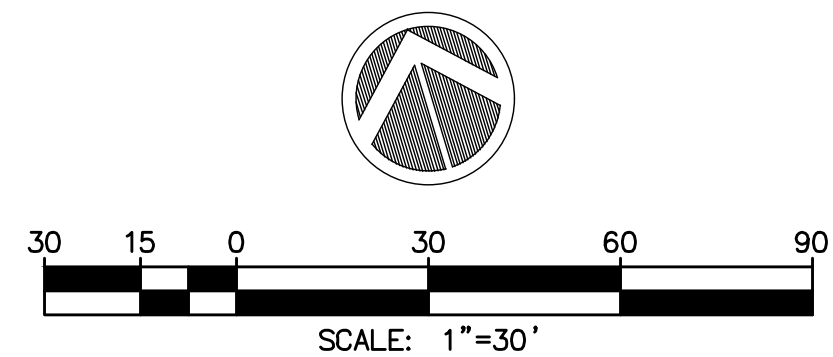

SIGHT DISTANCE EVALUATION INDICATES "L" AS LEFT TURN AND "R" AS RIGHT TURN. THEREFORE, THE TARGET DISTANCE FOR A LEFT TURN IS MEASURED LOOKING TO THE RIGHT, WHILE THE TARGET DISTANCE FOR A RIGHT TURN IS MEASURED LOOKING TO THE LEFT.

SIGHTLINES #1 AND #2 ARE BASED ON THE 85TH
PERCENTILE SPEED OF 39 MPH, ROUNDED UP TO

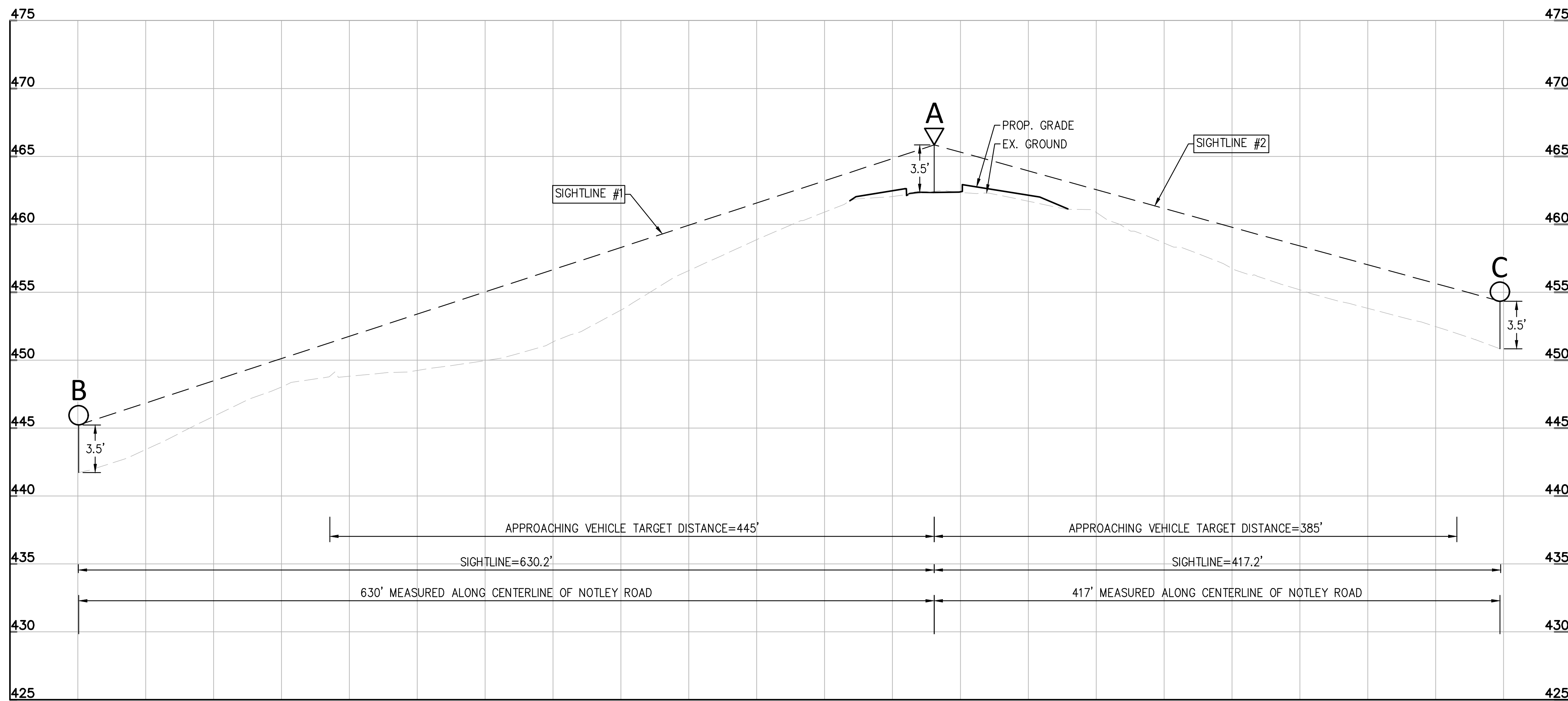
SIGHTLINE #2 NOTE:
SIGHT DISTANCE FOR ENTRANCE #2, SIGHTLINE #2 WAS MEASURED IN-FIELD TO THE EXISTING CROSSWALK AT THE INTERSECTION OF NEW HAMPSHIRE AVE AND NOTLEY ROAD. SITE VISIT INDICATES THAT THE SIGHTLINE EXTENDS BEYOND THIS POINT, BUT DUE TO TRAFFIC ON NEW HAMPSHIRE AVE, THE SIGHT DISTANCE COULD NOT BE FIELD VERIFIED BEYOND THE POINT SHOWN HEREON.
