Good Afternoon All,

Yesterday afternoon Attorney Michelle Rosenfeld brought to my attention (see email below) that there were some recent emails in this case that were not sent to her. On behalf of OZAH I sincerely apologize for that – it appears that this was likely a result of a “reply all” email where the underlying email did not have everyone’s email address on it that should have been on it.
