The Human Rights Office issued a Determination in the captioned matter, finding that reasonable grounds were presented to believe unlawful employment discrimination had occurred. The Determination and Chapter 27 of the County's regulations were sent to parties and counsel on August 269, 2024 (and on September 3, 2024, with additional counsel for Complainant). The Determination included an invitation for parties/counsel to participate in a conciliation session, pursuant to Montgomery County Code (MCC) Chapter 27, Article I, Sections 27-2 through 27-8.

The Respondent, through counsel, submitted a request for reconsideration, and the Complainant, through counsel, submitted an opposition to the request for reconsideration. MCC Chapter 27 does not provide a procedure for reconsideration of the agency's Determination. The step following a cause-finding Determination is conciliation. If the parties decline conciliation, or if it fails to settle the issues, the next step is certification of the case to the Human Rights Commission and referral for a public hearing.

Consistent with MCC Chapter 27, Article I, Section 27-2 and corresponding Regulations, the Director hereby certifies the captioned case to the Commission on Human Rights for referral to a Case Review Board and Hearing Examiner for public hearing. Hearing proceedings shall be conducted in accordance with the Montgomery County Code and corresponding COMCOR regulations.

The f Human Rights Office issued a Determination regarding the merits of the captioned complaint. The agency found reasonable grounds to believe unlawful discrimination in employment occurred. The Determination and Chapter 27 regulations were sent to the parties and counsel, with an invitation to participate in conciliation efforts toward an amicable settlement.

Filing a request for reconsideration, through counsel, Respondent effectively declined the invitation to a conciliation session under the auspices of the Human Rights Office. Consequently, this matter is deemed to be a failed conciliation under Montgomery County Code (MCC) Chapter 27, Article I, Section 27-2 and corresponding Regulations.

In accordance with MCC Section 27-2(b), the Director certified the case to the Human Rights Commission for referral to a Case Review Board and to a Hearing Examiner for a public hearing.

Pursuant to the MCC Section 27-2, it is hereby directed that the Montgomery County Government's Office of Zoning and Administrative Hearings be designated as the hearing examiner for the captioned case. A request is made that the OZAH arrange for a public hearing in which all outstanding issues shall be litigated. The hearing shall be conducted in accordance with the provisions of the Montgomery County Code Chapter 27 and Chapter 2A, and the applicable Montgomery County Regulations.

Upon completion of its proceeding, the Hearing Examiner shall submit a written report and recommendation to the Human Rights Commission, Case Review Board. A copy of the Hearing Examiner's report and recommendation shall be sent to the Parties, their counsel, the Case Review Board, and the Human Rights Office.

Complainant and Respondent are hereby reminded that voluntary settlement of the case is encouraged.
