## Background

FIN issued the banking supplies IFB twice, but both times failed to obtain a bid. FIN requests that the CRC recommend the CAO waiver of the Montgomery County Procurement Regulations, as permitted under Procurement Regulations §1.1.2, to purchase banking supplies via a Direct Purchase up to \$100,000 annually for the next five years.

#### **Motion**

Melissa Garner moved to recommend the CAO waiver of procurement regulation 4.1.9.1 of the DPO threshold, with a not-to-exceed amount of \$100,000 for the purchasing of bank supplies. This will come with a not-to-exceed date of two years. This is in accordance with Procurement Regulation, 1.1.2. Chris Mullin seconded the motion. The motion was approved.
