# **Background**

HHS submitted a new RFP #1153982, for the services provided under this Contract to the Office of Procurement on March 13, 2023. QSC is currently in the evaluation phase, but due to the retirement of the initial QSC lead, the evaluation process has been delayed. This second extension will allow sufficient time for the completion of the RFP process. Therefore, HHS is requesting the second extension beyond the term for one year with a ten (10) day kick out clause. A copy of the draft Amendment is attached. The Department considers the Contractor to be responsible, and the prices to be fair and reasonable. The estimated value of the extension is \$1,326,680.89.

### Motion

Robert Norris moved to approve the extension beyond the term with CentroNia, Inc., contract #1082507, for 1 year with a 10-day kick-out clause. This is at an estimated maximum not to exceed \$1,326,680.89. This estimate does not include the inflationary adjustment pending with County Council.
