Background

The Department of Technology and Enterprise Business Solutions (TEBS) is requesting the CRC's review and approval of Amendment # 19 to extend the contract term for an additional twelve (12) month period beyond its original term. TEBS is submitting this request in accordance with the Montgomery County Procurement Regulations, Section 4.1.12.3(a)(2), which states, "The valid performance or delivery due dates required by the County can be met by only one source." and Section 4.1.12.3(a)(1), which states, "Proprietary, patented or copyrighted items or information are available from only once source." The extension will allow for time to transition to a new system to be provided via a new competitive process.

Background

MCG Contract No. 1082494 was executed in July 30, 2019, for one year with three one-year renewal options. The Department of General Services, Division of Fleet Management Services (DFMS), requests a CRC review and approval for a one-year extension beyond the term. If granted, DFMS requests the term of MCG Contract No. 1082494 be extended from July 30, 2024, through July 29, 2025, with a ten-day kick-out clause to be enforced at such time when a replacement contract is successfully executed. In accordance with 4.1.12.3(a)(2).

Melissa Garner moved to approve the extension beyond the term with Capitol Fleet Service, LLC, contract #1082494, for 1 year with a 10-day kick-out clause. This is at an estimated value of \$350,000.00 and in accordance with Procurement Regulation, 4.1.12.3(a)(2). Chris Mullin seconded the motion. The motion was unanimously approved.

Background

CRC approved on May 2, 2024 No. 5 to modify the contract language and adjust the contractor's pricing for parts to provide the County with the best value. DGS is seeking approval from CRC for Amendment No. 6 which involves a new fee structure aimed at further reducing vendor pricing for parts and ensuring the best value for the County. The proposed new fee structure will help DGS and the County address other non-emergency, but critical pending tasks related to Contract No. 1107556, including

Department of Transportation (DOT) electric charger installations at the parking garages.

Motion

Melissa Garner moved to approve Amendment #6 with Electric Advantage, Inc., contract #1107556, to implement a reduced pricing fee structure. This amendment will allow for non-life safety projects to be completed for a maximum of 6 months. This is in accordance with Procurement Regulation, 4.1.12.3(a)(2). Chris Mullin seconded the motion.
