Minority, Female and Disabled-Owned Business (MFD) Program



Executive Summary

In FY23, the total dollars awarded towards certified Minority, Female, Disabled persons (MFD) firms were \$246,374,095. This is an unprecedented amount since the inception of the program. And it represents 22.60% of the total eligible dollars (\$1,090,391,062) subject to MFD participation. Minority spend is and will remain a top priority -- there's almost a quarter of a billion-dollar opportunity for businesses to take advantage of by participating in Montgomery County solicitations.

In FY23, African Americans continue to demonstrate strong performance in the non-professional services category receiving \$46,149,082, or 15%, of the \$303,269,317 of eligible spend. Likewise, Hispanic American businesses maintained high performance in the Construction category at \$24,225,681, or 24.17%, almost doubling the FY22 amount of \$12,558,698. Also, Female businesses received the highest dollar awards among the minority groups, both in Professional Services (\$38,341,987 or 7.47%) and Goods (\$24,117,969 or 13.91%) categories.

The County's MFD program recognizes six (6) groups of MFD firms that must be at least 51% owned, controlled, and operated by:

- African Americans
- Asian Americans
- Females
- Hispanic Americans
- Native Americans
- Persons with disabilities

The purchasing breakdown categories and goals CY24 are:

A new Disparity Study is currently underway. Updated goals based on this Disparity Study are expected by the end of Calendar year 2023. These goals will be the basis of the targets set forth in the MFD program in FY25 and beyond.

Framework of the MFD Program

Within the Office of Procurement, the Division of Business Relations and Compliance (DBRC) compiles an annual report on the Minority¹, Female and Disabled Persons Owned Business Program (MFD) which provides information required in accordance with Section 11B-61 of the Montgomery County Code and the Montgomery County Procurement Regulations.

The MFD Program assists registered vendors that hold at least one County-recognized certification in identifying opportunities, as either prime contractors or sub-contractors, for County contracts with an estimated dollar value of \$50,000 or more.²

There are six (6) minority certifications recognized and accepted by the County.

The MFD Program Specialist tracks and monitors contract awards and minority business compliance issues; conducts reviews and investigations of prime contractors' non-compliance and non-payments to minority subcontractors. These investigations may result in withholding progress payments, assessing Liquidated Damages, barring a vendor from doing business with the County for three (3) years, etc.

¹ Businesses owned by vendors in several socially and economically disadvantaged groups may be eligible for certification and participation in the MFD program, including African American, Hispanic American, Asian American, Native American, Female and Persons with Disabilities.

² Grants, utilities, intra/inter-governmental procurements are not subject to the MFD requirements.

The MFD Program continues to work towards increasing the participation of MFD businesses by working with County departments to identify opportunities for MFD contracting, providing assistance and resources to prime contractors, workshops, outreach events, pre-submission conferences and virtual and in-person networking events.

There are six (6) basic functions that define the duties and responsibilities of the MFD program:

- Procurement and MFD Program Education
- Compliance Enforcement
- Reporting
- Customer Service
- Outreach
- IFB and RFP Artificial Barrier Review

Outreach Activities and Networking Events

Outreach Events are targeted efforts, with the goal of attracting vendors from all disciplines and sectors of the business community. The objective is to invite minority vendors to participate in the County's procurement process. Events are hosted by the Office of Procurement and invitations are extended to government agencies and business organizations that have an interest in the County's MFD program. The events provide opportunities to local and minority vendors in seeking County's contracting information and other County policies related to local, small and minority vendors.

In FY23, the Office of Procurement hosted monthly online open house events, averaging 40-50 participants each time. The MFD program is showcased in the Pre-Submission conferences. Representatives from DBRC talk participants through required documentation, MFD participation goals, and how solicitation points are awarded during the evaluation process. The in-person "signature" events were the fall Procurement Fair and the Meet the Primes event in the spring. The Meet the Primes event is a new event, specifically targeting MFD businesses that want to network with Prime contractors.

Total Dollars & Value of RFPs by MFD Group

The Requests for Proposals (RFP) section of the MFD report is a result of proposals submitted in response to formal RFPs issued by the County during FY23. The report tracks the following information:

- MFD business groups and non-MFD businesses participating in the process only as prime contractors.
- Breakdown of number of awards.
- Dollar values for each group.
- Number of proposals submitted by each group.

The total dollar value for RFPs issued in FY23 was \$2,429,238,483. Of that amount, MFD businesses were awarded \$856,446,150 or 35.26%. Out of 217 total RFP proposals submitted, 70 (35.26%) proposals were submitted by MFD businesses. A total of 217 RFP contract awards were issued. RFP contract awards to MFD prime contractors were 19 (21.85%). More contract dollars were awarded to minority firms in FY23 -\$856,446,150, compared to FY22 MFD awards of \$110,832,930. Note that out of the \$856,446,150 that was awarded to the MFD businesses, 58.40% or \$500,200,000 went to Asian American owned businesses.

The Invitation for Bids (IFB) section of the MFD report is a result of bids submitted in response to formal IFBs issued by the County during FY23. The report tracks the following information:

- MFD business groups and non-MFD businesses participating in the process only as prime contractors.
- Breakdown of number of awards.
- Dollar values for each group.
- Number of bids submitted by each group.

The total dollar value for IFBs issued in FY23 was \$92,456,256. Of that amount MFD businesses were awarded \$32,015,224 or 30.91%. Out of 140 total bids responding to the IFBs, 19 (12.02%) bids were submitted by MFD businesses. Of the 72 IFB contract awards that were issued, MFD businesses received 11 awards. It is noteworthy that out of the \$32,015,224 that was awarded to the MFD businesses, 91.68% or \$29,350,000 were awarded to Female owned businesses.
