# LOCAL BUSINESS PROGRAMS



### **Message from the Director**



The Montgomery County Local Business Programs remain valued vehicles for local and small vendors, providing them with the opportunity to compete for contracting dollars with Montgomery County Government. In FY23, the County worked with many business organizations and local vendors and achieved a record high spend of \$305 million with Montgomery County based small businesses.

This year's Local Business Program Annual Report reflects the highest dollar amount spent with local small businesses since the inception of the Local Small Business Reserve Program (LSBRP) as

well as the highest percentage spend. We look forward to increasing our efforts and strengthening connections between the business community and county departments to support growth in County contracting activity with local businesses. ### **Executive Summary**

FY23 was a very successful year for the local business programs administered by Montgomery County Office of Procurement. The three local business programs are: Local Small Business Reserve Program (LSBRP), Local Business Preference Program (LBPP), Local Business Subcontractor Program (LBSP).

In FY23, the County spent \$305 million with local small businesses. This amount includes \$55,880,467 (31.3%) of total eligible spend under the LSBRP. This is the highest dollar amount spent with local small businesses since the inception of the program as well as the highest percentage spend.

In FY23, 86 formal solicitations were subject to the LBPP, which represented 54% of all formal solicitations that were issued.

In FY23, under the LBSP, certified local businesses were awarded \$44.7 million, which represents 4.5% of the total contract value subject to LBSP.

### **Support and Advocacy**

The Local Business Programs are managed in the Division of Business Relations and Compliance (DBRC). Besides external outreach, DBRC also functions as an internal advocate and liaison, connecting the local business community with county departments to facilitate information exchange and contracting resource development. In FY23, the County started conducting a new Disparity Study to determine if inequities exist in procurement and contracting that adversely affect Disadvantaged Businesses.

#### **Background**

The accomplishments outlined in this report result from several initiatives to stimulate economic growth through local contracting. In FY09, a partial governmental reorganization was implemented creating the Department of General Services and the Office of Business Relations and Compliance. The County Executive and County Council enacted new legislation and Executive Regulations to expand the County's ability to increase contracting with local businesses:

- 1. Local Small Business Reserve Bill #3-09 (April 30, 2009) -- Established the Director as the evaluator of a business's capacity to contractually perform.
- 2. Expedited Bill #23-15 (January 1, 2016) Amended LSBRP eligibility criteria for small businesses in the service sector.
- 3. County Executive Regulation #6-15 (March 23, 2016) -- Revised procurement regulations.
- 4. Local Business Subcontracting Bill #61-14 (May 17, 2016) Established Local Business Subcontracting Program.
- 5. Local Business Preference Bill #25-19E (June 23, 2020) Established Local Business Preference Program.
- Local Small Business Program Amendment Bill #39-19 (March 2, 2020) Increased LSBRP goal from 20% to 25%.

### **Marketing and Outreach**

### Local Small Business Reserve Program – DPO spending

Council Bill 39-19, LSBRP Amendments, was enacted on June 1, 2020. Among other general amendments, the Bill amended the LSBRP as follows:

(1) Subject to Method 2 regulations, a using department's procurement procedures must award a minimum of 25 percent of the using department's combined dollar value of contracts issued for goods, services, or construction, including direct purchases, to local small businesses.

(2) A using department must have a goal to award at least 50 percent of the combined dollar value of its direct purchases to local small businesses.

Direct Purchase is an informal procurement of goods, services, or construction that is accomplished under the direct authority of the using department head and not by the Procurement Director. Competition should be preserved with this method to the extent practical. Contracting with Local, Small, and MFD firms is encouraged. The current DPO threshold is \$10,000.

In FY23, total LSBRP eligible Direct Purchase Orders (DPOs) was **\$3,547,674.61**\*, and 43% of it or **\$1,526,530.76** were spent towards Montgomery County based businesses.

### Local Business Preference Program (LBPP)

The Local Business Preference Program (LBPP) is intended to bolster the County's economic growth and support the creation and retention of employment opportunities within the County. LBPP gives an extra 10% preference points on proposals or a 10% price preference on bids to Montgomery County-based businesses.

In FY23, 159 formal solicitations were issued. 86 solicitations were subject to the LBPP. The preferences were applied to 60 solicitations, which is 70% of the 86 solicitations.

### Local Business Subcontracting Program (LBSP)

To increase the participation of local businesses in certain large County procurement contracts, the County established a subcontracting goal for local businesses in procurement contracts with an estimated value to exceed \$10 million.

Local Business subcontracting goals are as follows:

- 1. at least 10% of the contract dollars awarded for each high dollar value contract should be awarded to a local business; and
- 2. at least 10% of the total dollar value of all high dollar value contracts in the aggregate should be awarded to local businesses.

A high dollar value contract means an initial contract award that is estimated to exceed \$10 million. To qualify, the business must have its principal place of business in Montgomery County defined as follows:

- 1. The business has its physical business location(s) only in Montgomery County; or
- 2. The business has physical business locations both in and outside of the County, but the County-based location(s) accounts for over 50% of the business's total number of employees, or over 50% of the business's gross sales.

In FY23, a total solicitation value of \$997,401,084 over \$10 million contracts was subject to the LBSP. Besides the two largest contracts that received full waivers, nine contracts reported with Local Business Subcontracting participation. In total, Local Subcontracting Businesses received \$44,755,600 which represents 4.5% of the total awarded.
