1. Article XXVII Private Wastewater Systems (<u>https://ecode360.com/7132759</u>)

24-163: Responsibility for operation and maintenance.

"The owner shall operate and maintain the individual private wastewater disposal facilities in a sanitary manner at all times and at no expense to the County."

24-166: Mandatory septic tank pump-out.

"Every on-site sewage treatment system in Queen Anne's County (except holding tanks and those systems capable of biological nutrient removal which are subject to a valid contractual agreement providing maintenance therefor) shall be pumped out at least once every five years. In lieu of such pump-out, the owner or owners of an on-site sewage treatment system may submit documentation to the County Department of Finance, certified by a liquid waste hauler licensed by the Queen Anne's County Department of Environmental Health, that based on an internal measurement of the solids in the tank, such solids are less than 1/3 of effluent height as measured by such liquid waste hauler and that the on-site sewage treatment system is in good repair and functioning as originally designed."
