Hello Jennifer,

I am responding to the messages below.

I went back and looked at my notes from our July 29, 2021 meeting.

In the attached message, Jackie provided a preliminary survey of 21 producers that received the OAG survey for leafgro.

During the meeting Jackie said there is larger data set of 61 farmers (57 table food producers and 5 CSA flower producers) that work with the OAG and our programs and services.

The 57 table food producers are the folks that may be interested in deliveries of leafgro in smaller trucks.

Jackie will need to help us to determine if she has additional responses from the larger data set of 61 farmers on the OAG survey for leafgro?

To Lauren's point- The County has over 558 farms covering over 70,000 acres of farmland. A majority of the acres in farmland for Commodity farms that produce corn, wheat, soybeans etc. encompass about 50,000 acres and these commodity producers do not use leafgro. Equestrian facilities do not use leafgro.

Please see the attached message from Caroline Taylor that she sent out to the MCA producers list asking the question about the smaller trucks for leafgro deliveries etc.

1. The subcommittee was asking "who are the 60 farmers"? I remembered from our meeting in early summer that Jeremy mentioned that these are farmers that "OAG has worked with", but I couldn't recall more info. SCA is interested to know if these are all table crop and flower farms? Lauren mentioned that there are some 400+ farms in MoCo, so what makes these 60 the potential leafgro users? We don't need the actual names of the 60 farms of course, but what made you mention them as farms potentially interested in Leafgro?

2. What is the cap for free leafgro- I think it is by \$ amount, correct? Is it the same each year? If not,

how much \$ was budgeted each of the last 3 years, and relative to how much of that was actually used by the farmers?

And finally, (and no worries, Jackie, I know you had a deadline you mentioned, no prob.), but when you have time, it would be great to understand and reconcile any differences between Lonnie's spreadsheet tracking bulk leafgro for farms and the OAG tracking of the same.

Then next steps are for me to put together a benefit/risk presentation to the SCA Board and hopefully move this to the next level.
