Hi Jessica.

Thank you for responding to our "Profitability and Viability of the Agricultural Sector". Your comments and suggestions were very helpful. We support your suggested wording changes to 7.4.6, 7.4.7c, and the additional action under 7.4.1. Below, we have identified a few small suggestions/comments for your consideration:

- Policy 7.4.1, suggested word changes in red: Eliminate regulatory and other barriers to broaden access to healthy food, agritourism, and agricultural employment through the support and diversification of the agricultural sector including agritourism, farm alcohol production, and farming in urban, suburban, and rural areas. Our intent here (and perhaps it can be achieved in other ways as you see fit), is to encourage farming in all areas of the county by eliminating barriers and unnecessary hurdles. Although farming is already obviously happening in the Ag Reserve, there is $much \ room \ for \ improvement \ in \ terms \ of \ regulatory \ and \ cost \ barriers \ to \ entering, \ expanding, \ and \ diversifying \ agribusinesses.$
- Policy 7.4.1 also seems to have guidance for specific issues related to urban and suburban farming (updating the zoning code, tax credits, public benefits). Would it be appropriate to also have something somewhat specific related to our interest in streamlining opportunities for farm business expansion and diversification under Chapter 50? Perhaps if it must stay general, updating language under 3.6.1 to say, "Continue to improve interagency collaboration to streamline review of development projects, as well as the costs of permitting, taxation, and other barriers to economically viable business expansion and diversification." Again, our intent is to remove barriers to farming in all areas of the county, and we have a well-documented list of issues in our "Profitability and Viability" document we shared with you, starting with Chapter 50.
- The Policy and Actions related to internet connectedness in the County (Goal 2.4) do talk about identifying areas that need coverage, but is there a way to strengthen this to intend that more be done that just identifying the problem areas? We, for example, know what areas of the Ag Reserve are lacking this service, and we hope that acting on that knowledge will happen in the next 5 (hopefully not 30!) years. Can an action item be more specific to tackling the issue? Perhaps acknowledging the need to identify internet service as a public utility that all must have access to?

Thanks again for your time working on this and discussing it with us last week.
