Phil & Mitsuko,

As you are aware, last Sunday I sent an email inquiry, on behalf of our committee, to a few neighbors in the Agricultural Reserve to determine their interest in obtaining broadband internet service. The response was entirely positive supporting an internet cable option. Word traveled quickly among adjoining neighbors and soon I was overwhelmed with responses. I've attached a partial list of those who would support enhanced internet communication.

Those people who contacted me were very enthusiastic regarding cable service, and volunteered the names of others in the area that would support the initiative. At this time it may be premature to expand our inquiry until we have had a meeting with the cable providers to determine service feasibility. We certainly have a sufficient number of people to justify a discussion with Comcast and perhaps Verizon. I was told that Verizon is providing Fios service in Poolesville and Berryville Road.
