Meeting on community solar in the AR zone

Hans would like to convene meeting to discuss a potential ZTA that would modestly increase the opportunity for community solar projects (less than 2MW, or 10-12 acres per project) in the AR zone. The basic idea would be to allow these projects as a limited use, subject to certain conditions, the most important condition being that no more than 2% of the AR-zoned land can be used for this purpose. We understand there are varied (and some cases passionate) views on this topic. We want to hear from the farming community before moving any further ahead. Please let me know if you are interested in meeting with Hans on this issue; we would be shooting for late November or early December.
