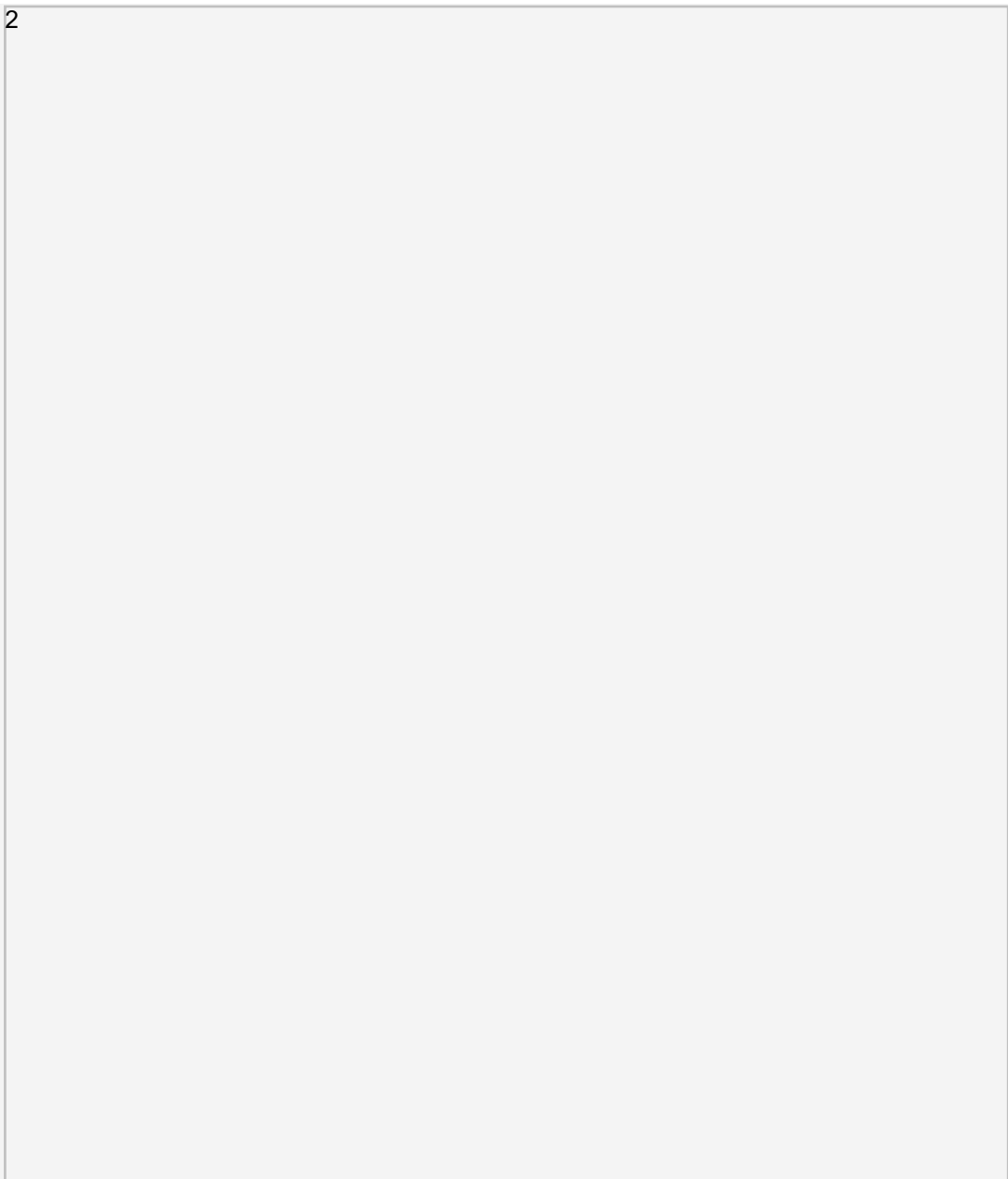
Important Notice For Montgomery County Residents and Businesses

Pesticide Laws in Montgomery County have recently changed. Most synthetic pesticides and herbicides are no longer allowed for cosmetic uses on private lawns, playgrounds, mulched recreation areas, or private childcare facilities. The law applies to all homeowners, tenants, property managers, and lawn care providers.

A mailer is being sent to all properties in the County, in English and Spanish. Additional translations are available in Amharic, Chinese, French, and Korean. Partial contents of the mailer are included below.
