FY25 Operating Budget Including Response to ASAC's 2/14/24 Letter

Deputy Director Lex Lepiarz is unwell/absent, and there will be no update regarding Maddie's Fund, and Dr. Lawrence provided a basic shelter update. Some updates include the following:

- MCASAC's 10-year anniversary adoption event is now through 3/10/2024, and all adoption fees on all animals are just \$10.
- Currently 38 pets are in the Home-to-Home program.
- Re: broken dish sanitizer we now have 2 functioning dish sanitizers.
- There are 2 dog play groups a day on Sundays, Wednesdays, and Thursdays.
- In the dog area, landscaping and the fencing/gate issues are being worked on.
- Working on portals in cat adoption room volunteers helping with it too.
- Volunteer retention from 2020 2022 was 47%.
- The Fear Free training has no impact on volunteer retention.
- Transferring online pet licensing work to Pet Data. Will be down from 3/13/2024 3/18/2024. On 3/18/2024, Pet Data will handle from then on.
