IV. Bonnie White gave update on the spay/neuter program on behalf of Exec. Dir. 6:56 p.m. Carolyn Hairfield

• There were 72 spays and neuters from February to September, including 47 cats (60%), 25 dogs (32%), and six no-shows (8%).

- Recipients of public assistance have access to low-cost and reduced-fee services, both of which are significantly lower than the OAS's cost, resulting in 70% of costs being subsidized.
- OAS is applying for grant assistance and putting out an open solicitation to bring on a relief vet. These efforts will help fund and expand the S/N Program.
- Donations to the shelter can be made online via the MCASAC website under Get Involved. A donor can reference the purpose of a donation by typing it next to their name (i.e. spay/neuter program, pert food pantry).

IIV. Committee Member Objectives – Areas of Interest to Focus On: 7:36 p.m.

- Beth and Georgia will meet and contact Caroline to determine who they should work with in the
 Public Information Office to reach the underserved in Montgomery County about OAS's services
 including disseminating messages to the underserved and, perhaps, connect with the Hispanic
 Marketplace, Tele Mundo, and other media or marketing services to help spread the message
 effectively.
- Jennifer emphasized the importance of messaging, especially during the FY27 budget development process. For example, explaining that residents' current financial struggles become OAS's struggles because residents will be looking to OAS for help and support or be forced to surrender their pets. Bonnie explained that it will be challenging to ask for and offered some guidance to Bonnie, who explained that it will be challenging to ask for enhancements without proposing offsetting cuts to existing programs.
- Committee members were reminded that they are invited to attend Council hearing on Oct 28 where Councilmember Evan Glass will be recognizing "Adopt a Shelter Dog Month" on Oct. 28th.
