- Board voted (17 Yes, 0 No) to approve the 9/17/2025 Minutes (1<sup>st</sup> Sheriff Uy/2<sup>nd</sup> Judge Bernard)
- Board voted (18 Yes, 0 No) to approve the proposed 2026 CJCC Meeting Schedule (1<sup>st</sup> Sheriff Uy /2<sup>nd</sup> Eric Schneider)

2. Standing Agency Updates

- Circuit Court (Judge Bonifant)
  - As of Oct 31, 2025 the Circuit Court has 950 pending Criminal matters which is approx. 250 more cases than at the beginning of the pandemic
  - Through 10/31/25, the court holds approximately 9 criminal jury trials/month
  - The Court was down 2 judges throughout the year
    - In Sept 2025, Gov. Moore appointed James Dietrich to Montgomery County Circuit Court
    - Currently there are 6 candidates to replace retired Judge Storm
  - Judge Bonifant raised concerns that the OPD continues to be down 5 attorneys and noted there could be around 80 cases/attorney
  - Statewide Behavioral Health in the Criminal Justice System – chaired by Chief Justice Fader and Asst Gov. Miller
    - Judge Bonifant is the Vice Chair on the Data Subcommittee
- District Court (Judge Koch)
  - District Court is currently down 2 judges which will become 3 by end of year.
    - Judge Koch does not believe we will get any new judges anytime soon (likely not til Fall 2026)
    - We are even short on visiting judges
    - Problem Solving Courts Update:
      - Currently in talks with MCPD to get a representative on the Problem Solving Courts Team as this is best practice
      - Continuing to pursue a Veterans Court

Questions/Comments from the Committee:

- A question was asked regarding the Courts reports that we are understaffed with regard to Judges and if that is a morale issue

- Both Judge Bonifant and Judge Koch note their team is dedicated to the job and there is no issue of morale concerns from their staff. We regularly meet with our Judges to review cases, making moves where necessary
- MCPD (Chief Yamada)
  - Highlighted a positive conviction of a 2023 gang related homicide which was a result of the partnership between the Gang Intelligence Investigators and prosecutors at the SAO
  - 5D is actively engaged with a 14 yr old male who is connected to 52 incidents/13 arrests
  - Notes the public (especially youth) need to be diligent when attempting to sell property (clothes/shoes/etc) on Social Media; MCPD continues to see these transactions turning into robberies
  - Introduced Capt. Tony Galladore who oversees the newly restructured Operational Intelligence Division, bringing the Drone as First Responder (DFR) and Real Time Intelligence Center (RTIC) under the same division for better communication within the department.
    - Capt. Galladore noted as we move the Drone Program to be more mobile with the Drone in a box option, it will increase the number of hours this program can function
    - Capt. Galladore also noted MCPD is intentionally being very transparent with the Community about the use of Automated License Plate Readers and the Drone Program among other things as a way to keep the Community informed
  - Chief Yamada noted on average Montgomery County has 20 homicides a year, and we may exceed that by year end. In contrast, our neighbors- Prince George's County have 63 and DC has 122 homicides respectively as of the start of Nov.
- State's Attorney (John McCarthy)
  - Highlighted the successful City of Rockville PD Gun Buy Back event and that the City of Takoma Park looks to do a similar one soon
  - His office will be publishing a dashboard within the next 30 days to show Dispositions and Citizen Complaint data
  - Noted ICE currently is offering \$50K signing bonus for attorneys with a starting salary of \$167K
- Office of the Public Defender- Montgomery County (Sean Mukherjee)
  - Agreed with others that his office is understaffed - Attorneys and Support staff
  - Noted the need of additional financial resources within the Office of the Public Defender

- Interest in working with McCarthy on ending or significantly amending the Citizen Criminal Complaint Process in Maryland as it diverts valuable time and resources

3. Briefing: Hate/Bias Incident Collection in Maryland

Maj. Greg Phillips, Maryland State Police, Maryland Coordination and Analysis Center (MCAC)

Zachary Markenson, Hate Crimes Intelligence Analyst, MCAC

- Maj. Phillips and Mr. Markenson praised Montgomery County Police for their best collection processes in reporting Hate Crimes and Hate Bias Incidents
  - Maj. Phillips and Mr. Markenson note that while there is a State mandate to collect this information, it is not as widely reported, and processed in other Maryland jurisdictions
  - Maj. Phillips and Mr. Markenson do road shows in jurisdictions; on Fridays they meet with Community/Public members to train them on what Hate Crimes and Hate Bias Incidents are and then bring in Law Enforcement on Saturday to train them on how to collect/report this information to MCAC
- Maj. Phillips and Mr. Markenson presented a presentation which can be found at the end of these minutes:

- Defined the difference between a Hate Crime and a Hate Bias Incident both of which must be investigated by law enforcement and reported to MCAC
  - Incidents can and do evolve into Crimes
- Maryland defines 9 Protected Classes – Homelessness is a Protected class within Maryland specifically
- Reviewed Maryland Hate Crime Statutes
- Highlighted the difference between what was traditional incident reporting and what is now required under the Hate Bias Incident Reporting
- Shared Hate Bias Data
  - Top 3 Motivations:
    - Race (Anti-Black or African American)
    - Religion (Anti-Jewish)
    - Sexual Orientation (Anti-Gay Male)
- Noted that within the State of Maryland Hate Bias Report, Incidents are counted by individual motivation meaning if an incident involves Race, Religion, and Sexual Orientation as an example, this 1 incident would count

- as 3 motivations – the FBI report only counts 1 incident and attributes it to 1 motivation even if several are present
- Discussed several cases that MCAC received over the past year from various jurisdictions in Maryland to show the incident and how it was classified and how incidents are a pathway to violence or crimes!

    - how to report via the form, 311, or MCPS (for school related incidents)
  - Reporting of incidents is confidential and can be submitted anonymously
  - Described the process from the Complainant filling out the form, to notification of key partners, to determining who will address the complaint and a follow up letter which is sent to complainants if they provide contact information
  - The portal has collected 138 complaints since 12/4/2024

# HATE CRIME VS. HATE BIAS INCIDENT

Hate Crime: A crime or a threat of a crime targeting one person or a group of people because of their protected class status.

Hate Bias Incident: Any act or expression of hostility or aggression that is motivated, at least partially, against a protected class but does not constitute a crime under state or federal law.





# MARYLAND HATE CRIME STATUTES

## MD. Criminal Law Code § 10-302

A person may not deface, damage, or destroy, or attempt or threaten to deface, damage, or destroy, personal or real property that is owned, leased, or used by a religious entity or for any religious purpose including:

1. a place of worship;
2. a cemetery;
3. a religious school, educational facility, or community center; and
4. the grounds adjacent to them.

## MD. Criminal Law Code § 10-303

A person may not, by force or threat of force, obstruct or attempt to obstruct another in the free exercise of that person's religious beliefs.

## MD. Criminal Law Code § 10-304

Motivated either in whole or in substantial part by another person's or group's race, color, religious beliefs, sexual orientation, gender, gender identity, disability, or national origin, or because another person or group is homeless, a person may not:

1. commit a crime or attempt or threaten to commit a crime against that person or group;
2. deface, damage, or destroy, or attempt or threaten to deface, damage, or destroy the real or personal property of that person or group; or
3. burn or attempt or threaten to burn an object on the real or personal property of that person or group;



# MARYLAND HATE CRIME STATUTES

MD. Criminal Law Code § 10-305 & § 10-305.1

A person may not deface, damage, or destroy, attempt or threaten to deface, damage, or destroy, burn or attempt or threaten to burn an object on, or damage the real or personal property connected to a building that is publicly or privately owned, leased, or used, including a cemetery, library, meeting hall, recreation center, or school:

1. because a person or group of a particular race, color, religious belief, sexual orientation, gender, gender identity, disability, or national origin, or because a person or group that is homeless, has contacts or is associated with the building; or
2. of there is evidence that exhibits animosity against a person or group, because of the race, color, religious beliefs, sexual orientation, gender, gender identity, disability, or national origin of that person or group or because that person or group is homeless.

**A person may not place or inscribe an item or a symbol, including an actual or depicted noose or swastika, whether temporary or permanent, on any real or personal property, public or private, without the express permission of the owner, owner's agent, or lawful occupant of the property, with the intent to threaten or intimidate any person or group of persons.**


# MANDATE TO COLLECT

According to Maryland Code Public Safety § 2-307 (b)(1), the Maryland Department of State Police **shall collect and analyze information about incidents** apparently directed against an individual or group because of race, color, religious beliefs, sexual orientation, gender, disability, national origin, or homelessness.


- Each local law enforcement agency and the State Fire Marshal shall provide the Department with the information described in paragraph (1) of this subsection.




# TRADITIONAL INCIDENT REPORTING

# 10-YEAR HATE BIAS TREND







# HATE BIAS PATHWAYS TO VIOLENCE

## Baltimore County Resident

- January 2022, offender was the suspect in the placement of a noose on a porch and in the distribution of offensive flyers placed inside Ziploc bags in Calvert County
- May 2023 a concerning flyer in a library copier in Anne Arundel County
- May 2023 roommate and the offender argued over his intention of constructing and burning a wooden cross in Anne Arundel County

### **W.A.R.**

White Aryan Revolution  
"Fighting for White rights"

1. We are sick and tired of watching our rights as White Americans disappear at a rapid pace.
2. We are sick and tired of seeing blm riot, burn our cities down, loot, rob, kill etc.
3. - Keeps Anonymity: report without providing info
- Provide training and positive education to community members

# Montgomery County Hate/Bias Incident Complaint Portal

- Confidentiality
- Reporting incidents will help Montgomery County track trends in hate-based incidents, even if they are not crimes. You can also choose to submit anonymously, but we will not be able to follow up with you about the incident.
- Montgomery County stands firm on privacy and inclusivity. We do not ask about anyone's immigration status. The county does not engage in immigration enforcement or investigations. Our commitment is to foster a welcoming community for all residents, regardless of background.



# Montgomery County Hate/Bias Incident Complaint Portal

- The process
  - Complainant fills out the form
  - Notification: Annabelle Estrada, Hate Bias Incident Coordinator, CRSRD Director, and Deputy Director
  - The matrix is used to decide where the complaint should be sent
  - Follow-up letter to confirm that it was received and resources (if the complainant provides contact information)



# Montgomery County Hate/Bias Incident Complaint Portal

## Montgomery County Police Department

On behalf of the Montgomery County Department of Police, I am contacting you to provide resources after the distressing experience you have undergone as a victim of a hate/bias incident. Your courage in coming forward and reporting this incident is commendable.

As a victim of a hate incident, please know that there are resources available to you through Montgomery County. These resources include the following:

- **Office of Human Rights** –Understand that some hate-motivated incidents do not rise to the level of a hate crime but may still leave individuals feeling victimized. Some examples include name-calling, offensive language, or hateful speech/writings. For additional information, locate the Know Your Rights flyer from the Office of Human Rights webpage, <https://www.montgomerycountymd.gov/humanrights/know-your-rights-stop-hate.html>
- **The Committee Against Hate/Violence** - If personal property was damaged as a result of a hate/bias incident, individuals and private institutions may be eligible under County law for reimbursement for property damage up to a limit of \$2,000 for each hate/violence act, and up to \$4,000 for medical expenses incurred from physical injury. We understand that this may be a challenging time for you, and we want to assure you that you are not alone. # Montgomery County Hate/Bias Incident Complaint Portal

- For reported incidents that involve public property that has been defaced by writing, drawing, or painting of bias-related graffiti, complaints will be referred to the appropriate agency for removal of the graffiti and closed administratively.
  - For Montgomery County signage/roadway, email the complaint to:

  - For Maryland State Highway Administration property, fill out an online request form at <https://www.roads.maryland.gov/mdotsha/pages/index.aspx?pageid=519>
  - Property defacement occurring within the corporate limits of an allied jurisdiction, or property belonging to Maryland National Capital Park and Planning Commission, should be referred to the appropriate allied agency for disposition (Takoma Park Police Department, Rockville Police Department, Gaithersburg Police Department, or MNCPP Police Department)



# Montgomery County Hate/Bias Incident Complaint Portal

- For incidents that involve the allegation of a crime that affects a person, such as an assault, harassment/stalking, the misuse of communications equipment, damage to private property, etc., the complaint should be referred to the appropriate agency where the incident occurred if contact information is provided by the filing complainant (Montgomery County Police Department, MNCPP Police Department, Takoma Park Police Department, Rockville Police Department, Gaithersburg Police Department, or Metro-Transit Police Department) so an appropriate investigation can be conducted. If the complaint is filed anonymously, the complaint will be closed administratively with no follow-up.



# Montgomery County Hate/Bias Incident Complaint Portal

- Verbal Offensive Language – 10 (7.25%)
  - Woman yelled at by unknown man – stated he had a better time in another state where there are no black people
- Graffiti – 33 (23.91%)
  - Hate graffiti on overpasses, tunnel of park, bus stop signs, stickers on vehicles and signs, and business buildings
- Email From Same Woman – 46 (33.33%)
- Complaints regarding discrimination and unfair termination/treatment - 2 (1.45%)
  - Woman reported feeling discriminated against based on name and race, sent to Baltimore Police (their jurisdiction)
- 138 total since December 4th, 2024



# Montgomery County Hate/Bias Incident Complaint Portal

- A complaint added in portal that was also documented by police – 10 (7.25%)
- Derogatory language and slurs on social media – 2 (1.45%)
  - Believes MCPS teacher is promoting hate and violence based on their beliefs
- Voicemail 1 (.72%)
  - Antisemitic voicemail sent to Jewish organization
- Written threat related to where they are employed and how the business runs – 2 (1.45%)
  - Unhappy that company follows DEI practices
- Unable to categorize - 32 (23.19%)
  - Hateful signs posted in neighborhood, roommate problems, woman saying she is going to be jumped, etc.
