A question was asked about whether the new federal immigration policy is impacting the number of reports of suspected abuse. Ms. Erstling advised that there has been no impact thus far. The agency is monitoring to see if the new policy does have an impact on the child protection system.

#### Sub-panel on Developing a Culture of Support for Agency Staff

Ms. McNeely advised that Lisa Merkin has selected two speakers recommended by the MCCRP to make presentations to the agency staff - Dr. Patricia Carrington, a psychiatrist who works with children and adolescents, and a play therapist. At least one presentation will be offered in March, which is Social Worker Month. If both presentations cannot be scheduled in March, the other session will be scheduled in the Spring.

The work of this subpanel seems complete. Ms. McNeely will contact Lisa Merkin to inquire about other potential topics for the MCCRP to undertake.

#### **Sub-panel on Support for Transitioning Youth**

Ms. McNeely, chair of the Sub-panel, advised that has begun a review the reports submitted by other advisory panels and commissions to the Montgomery County HHS Committee in October 2024 to see if other groups have a shared interest in this issue.

Laura Brown has conducted research on the web for effective and promising practices but has not found much information.

#### **Panel Vacancies**

The County posted a MCCRP vacancy notice in December. Three applications were received. Ms. Merkin is working to schedule interviews with the applicants.

Recent departures from the MCCRP include Kenneth Beale, Ronald Whalen, and Tinuade Akinshola. This is also the last Board meeting for Laura Coyle.

Ms. McNeely will work with Ms. Merkin to repost the vacancy notice.

Ms. McNeely thanked Ms. Coyle for her years of service and her many contributions to the MCCRP.
