The agency is providing train-the-trainer training for resource families related to the Center for Excellence (CFE) project. Resources families will participate in training over 16 weeks. The agency is trying to identity a trainer to work with biological parents for the CFE project.

Panel Speaker for Staff

Ms. Coyle has been working with Dr. Aaron Bryant, Curator of Photography, Smithsonian National Museum of African American History and Culture, to identify a date for the presentation. They hope to schedule a date in March during National Social Worker Month.

LGBTQ Subcommittee

The subcommittee is continuing to work toward a draft white paper. Ms. Katy Dunn is developing an outline for the white paper. The end product will include a narrative of the findings, identify inconsistencies in practice, identify areas where additional information is needed, what is needed to support staff, and recommendations and potential identification of resources. The end product with be shared with the staff that participated in the survey and be incorporated in the Panel's annual report.

Recruitment and Retention Subcommittee

The final edits on the survey have been completed along with a cover letter from the Panel explaining the request and how the information will be used.

Next Steps: Ms. Dunn will advise Mr. Chris Plummer, President of the Montgomery County Foster Parent Association, that Ms. Laura Brown and Ms. Brier will be providing the final survey to him for distribution to his membership.

Mr. Ronald Whalen will join the panel beginning with the March 2022 meeting. Ms. Lisa Merkin will work with the County to readvertise the Panel vacancies.

Spring Forum

Ms. Kay Farley advised that the 2022 Spring Forum will be on May 19^{th} from 6:00-8:00 pm on the Zoom platform. She advised that the first meeting of the planning committee took place earlier in the day on February 8, 2022. There seemed to be consensus to focus on high school youth with mental health and substance abuse issues. S. McCoy Roth volunteered to join the planning committee along Ms. Farley.

Transition Youth Services Presentation in March

Ms. McCoy-Roth advised that the agency provided a presentation about Transition Youth Services to the Board of Social Services recently. The presentation was an overview of the program and referenced the Ready By Twenty-One manual.

Next Steps: There was consensus to invite the unit supervisor to meet with the Panel at the March 2022 meeting.

Co-Chairs for 2022-2023

Ms. Brown and Ms. Stacey McNeely agreed to serve as co-chairs for the coming year.
