- Pat Grant and Betty Lam announced the appointment of a new Chief Health Officer, Dr. Kisha Davis, who was officially <u>confirmed</u> on November 15, 2022. Dr. Davis is a Montgomery County native and pediatrician by training and will begin her duties on December 12, 2022. Betty Lam recommended that the group extend an invitation for Dr. Davis to speak with the committee given her background in health equity.
- Tiffany Ward announced that the Effective Law Enforcement for All (<u>ELEFA</u>) Review of the Montgomery County Police Department audit is complete and a press conference was held earlier in the day. RESJAC members are expected to review the report and provide the County Executive with feedback.
