#### IV. NEW BUSINESS

- Marquette asked Committee Chairs to present topics or activities for their committees:
  - Family Investment Committee Chair, Michael Lipsitz reported that the Committee met by phone and suggested a focus on benefits provision for people who are housing insecure, for example, how to provide addresses for COVID vaccinations for people who are homeless
    - Oscar offered to bring an expert from the income support group to brief the BSS, provide an overview and data and assist the Committee in taking a deeper dive into the topic
  - o <u>Legislative Committee Chair, Samaura Stone</u> reported that the Committee suggested a briefing on State and County legislation.
    - Oscar noted that this past State session activities were conducted in a centralized way so the liaison and interaction was a little different from past years
    - Oscar offered to reach out to the legislative liaison, Leslie Frye, to have her brief the BSS, provide an overview of the process, timeline, types of legislation they track
  - Outreach & Communication Committee Chair, Chante Leverette, reported that the Committee had discussed mission and communications suggestions via email and will schedule a regular meeting time, the first call will be this Thursday, May 6, at 6:30 pm.
    - Oscar offered to bring in Dennis Linders, Senior Administrator, PACS, to brief the BSS on the agency's and BSS's public information and social media policies
  - Adult Services & Child Welfare Services Committee, Marquette noted that the Committee Chair, Jean Swift, is unavailable at the moment due to personal issues, and will meet when she becomes available.
- Status on inquiry of a board email address and intranet page. Marquette requested that Oscar and Mina look into who to contact to approve items to post to the Facebook page and to consider the possibility of having a BSS page similar to the Recreation Advisory Board page: https://www.montgomerycountymd.gov/rec/about/advisoryboard.html
  - Oscar offered that he and Mina will research this, contact the agency's Public Information Officer, and try for a quick turn around
- Open forum to discuss any upcoming legislation, community engagement opportunities or Social Services business. The BSS had a wide-ranging discussion:
  - How to find, disseminate and participate in volunteer opportunities
  - Possibility of attending events to talk to community members to hear their needs and to provide information on County services
  - Follow-up on last month's discussion on difficulties in some communities in accessing COVID vaccines
  - Building trust with community members to understand their needs and assist in accessing government services and the strengths of various outreach and communication approaches

- How to conduct surveys, needs assessments, obtain input from community members, find reliable sources of input to determine needed services, service utilization, barriers, the roles of various government and non-profit case workers and service providers
- Marcy asked the BSS members to send her input to inform her participation in a focus group in July; she will send an email reminder

## V. REVIEW OF ACTION ITEMS and ADJOURN MEETING

- Continue research into BSS Internet page
- Committees continue to meet to before the next BSS meeting
- Oscar will approach key individuals to provide briefings to the BSS on income support, legislation, and PACS, possibly with at least one presentation at the June BSS meeting

- Marquette adjourned the meeting at 5:41 pm, with a motion by Kendall, second by Chante
