### **Consent Agenda**

1. T-Mobile application to add three 96"-high panel antennas at the 55' level on a 61'-high silo on Steven H. Steinberg property located at 15021 Dufief Mill Road in Gaithersburg (201407-28). *Minor Modification*.

2. Sprint application to add three 56"-high panel antennas at the 150' level on a 150'-high monopole on MCPS property located at 300 Olney Sandy Spring Road in Sandy Spring (201407-06). *Minor Modification*.
