**Search the Notary Public database**

if you search for a notary and are unable to locate that person as being currently commissioned, it may be that their commission has been automatically extended because of the State of Emergency.

## Certification of Notarized Documents during COVID-19

### License Department

The License Department certifies documents that have been notarized by a Montgomery County Notary Public. While the Montgomery County Circuit Court is closed to the public, documents can be certified via the Court's drop box or via mail:

#### 1. Drop Box

- a. Drop your envelope in the Circuit Court's public drop box (located right outside the Maryland Avenue entrance to the Circuit Court at 50 Maryland Ave in Rockville)
  - i. Write "License Department" with your name and phone number on the envelope
  - ii. In the envelope, include the following:
    1. Your request for certification,
    2. Your document to be certified,
    3. A self-addressed and stamped envelope (so the document can be mailed back to you), and
    4. A check made out to the "Clerk of the Circuit Court" for \$1.00/document needing certification.

OR

#### 2. Mail

- a. Mail your envelope to the Montgomery County Circuit Court at 50 Maryland Ave, Rockville, MD 20850
  - i. Write "Attention: License Department" in the address
  - ii. In the envelope, include the following:
    1. Your request for certification,
    2. Your document to be certified,
    3. A self-addressed and stamped envelope (so the document can be mailed back to you), and
    4. A check made out to the "Clerk of the Circuit Court" for \$1.00/document needing certification.
