- Maryland Network Against Domestic Violence: Asked for sponsorship for annual meeting on 24 OCT 2023

Have not spent any sponsorship money yet

County funds; does not come from restricted budget; does need to be approved through county but not an issue

Motion to sponsor MNADV at \$100 level; Motion seconded; Motion carried

- Montgomery County Code required training: Maryland Open Meetings Act, Basic Parliamentary Procedures, and Montgomery County Public Ethics Law
  - o Aim to have done by next meeting

#### 4. EXECUTIVE DIRECTOR REPORT / JODI FINKELSTEIN

- Two new interns (Jr. at Paint Branch, Sr. at Blair; M/W, 4 hrs per a week)
- Conference sponsored by Baltimore Record; Jodi F. will be moderator for the panel; 25 OCT
- Commissioner Royster represented commission at DV and Breast Cancer Awareness Month events
- Community Budget Meetings (variety of languages available)

#### 5. COMMITTEE REPORTS

## Policy and Legislation / Co-Chairs, Commissioners Royster and Meister

- PALS Committee moves to recommends commission host Lobby Day this year; motions carries
  - Explanation of Lobby Day (e.g., champion legislation to state legislatures)
  - o Looking at second week of December (13/14 DEC tentative)

## Program Planning / Chair, Commissioner Enendu

- Reminder working on virtual career fair, 16 NOV, 7 8:30pm; in need of speakers (non-traditional careers STEM, fire department, in need of military)
  - o Target group, female middle/high schooler
  - Need 8 speakers
- Bringing back career series in Spring 2024
  - o Would like to use former Commissioners with experience in this area
  - O Updated courses (e.g., entrepreneurship, online interviews)
- Sexual health & wellness
  - o Have doctor on board; finalizing details
- Looking to leverage former commissioners
- Question: DV programming? Example of MCASA's credit program

## Budget / Chair Clark

- Sponsorships: \$5,000
- Two pots of money (restricted money the commissioned raised vs county funding from the budget process)
- Human Trafficking: \$2,500 (being spent)
- Re-entry Program: \$50,000 (encumbered; need to go through hiring process; examine what commission did pre-COVID)
  - o Have contract through HHS to hire someone
  - o Pre-COVID: Commission did tour/focus group in jail on help; said they need reentry program; majority of existing re-entry programs are faith based
  - o Pre-COVID: Commission ran drop in groups by LCSW (not counseling)
  - o Re-entry program was for women in Montgomery County

## Strategic Planning and Research Evaluation Committee/ Commissioner Romero

- Successful Strategic Planning last month
- Introduce Strategic Plan to the county
- Action Plan has all the information in once place; living document
- Continue to build out partnerships to help commission's mission; add partners to the spreadsheet that the commission can work with
  - o Could help identify speakers for programming
- Discussion on the three issues central to the strategic plan (i.e., women's economic health, women in leadership, women's health and safety)
  - Unclear if there was a past commission vote to adopt the three priorities; Will do a formal vote to adopt the three priorities at our next meeting in NOV
  - Vote on the issue areas not in past minutes, so will vote on the issues areas next month
- Motion to have commission focus its efforts on one of the primary issues areas (not which priority though)
  - Motion moved to next month
