Dear Guests of the 2024 Women's Legislative Briefing,

Over the past few years, right-wing lawmakers across the country have been working to take away women's fundamental rights and freedoms. From abortion bans to attacks on transgender youth, Americans are being stripped of their basic rights just for being who they are. It's horrific and against everything that our nation should stand for. During this year's women's legislative briefing, we once again fight for progress – together.

In Congress, I'm proud to fight for legislation centered on fair wages and working conditions for women. I helped pass the Pregnant Workers Fairness Act into law to require employers to provide reasonable accommodations to pregnant women. I also cosponsored the Paycheck Fairness Act to address wage discrimination on the basis of sex. To this day, women typically earn 82 cents for every dollar earned by men, which is why I strongly support the wage gap transparency bill proposed in Maryland's General Assembly. We must combat discriminatory practices and policies on the local, state, and federal levels, and I'm confident that we'll get the job done.

In Maryland, I also know that there are several legislative priorities on the agenda intended to protect and support women, including a bill to create programming for women transitioning from prison to our communities and a bill to notify law enforcement officers when someone fails a background check when trying to purchase a firearm. I'm supportive of both of these measures and I've worked to ensure similar initiatives are achieved on the federal level. I helped pass into law the Safer Communities Act, which created a background check system for those with misdemeanor domestic violence convictions to keep guns out of their hands. We also have to protect abortion care across our country and support those seeking reproductive health care in our state. Reproductive care has allowed women to further their education and careers, lift themselves out of poverty, and pursue a better life. By taking away reproductive freedoms, we are sending the wrong message to Americans about how we value women and their futures. We won't stand for it.

Today's briefing is a powerful statement of our collective commitment to breaking down barriers for women. Your efforts in planning and executing this event amplify the voices that often go unheard and bring to light the critical issues that demand our attention and action. Together, with the commission's hard work, we are making strides towards a more equitable future. It's an honor to stand with you in this mission, and I remain committed to advocating for policies that protect and empower every woman in this nation.
