Hi!

I'm Eleanor Clemans-Cope, a junior at Richard Montgomery High School and climate activist with Sunrise Rockville and MoCo on Climate.

I read the entire CAP, from beginning to end. Its goals are excellent, a 100% emissions reduction by 2035 is exactly what we need. It also does a very good job outlining the areas where we should reduce emissions. The CAP is a good step forward for Montgomery County. But it's also a step that took two years, and in that time, we saw little to no actual action to go with the planning. My biggest comment is that we need action on climate, and we need it now.

Here is a short list of my comments on the CAP:

If we start now, MoCo could become a climate leader, and an inspiration. My generation depends on it.

Also -- This isn't related directly to the CAP, but I think it's necessary to include in my comments. I went to the Youth Town Hall on the CAP, and it absolutely felt like it was talking down to young

people. I thought that I would have space to comment on the CAP, instead, the public chat was off in the main room and in breakout rooms, and most of the questions in breakout rooms did not directly address the CAP at all. The presentations that were given about what was in the CAP focused on parts of the CAP that are not central to the critical goal of emissions reduction. The whole Town Hall felt like an experience that was meant to tell us what to do, and not an experience that was meant to solicit our comments.
