Today, the GO Committee will review the Executive's recommended supplemental appropriation to the FY19 Capital Budget for the Department of General Services (DGS), Council Office Building Garage Renovation (COBG). The appropriation is in the amount of \$1,990,000, and the source of funds are GO Bonds.

The County Executive transmitted his request on January 15. The Council introduced a resolution to approve this supplemental appropriation on January 22. The transmittal memo, draft resolution, and project description form are attached on © 1-5. A public hearing was held on February 12, 2019 and there were no speakers.

This project provides for the design and construction of repairs to the COBG. Initial items approved in the scope of the project include renovation and repairs to the concrete deck, structural steel, drains, post-tensioned concrete tendons, curbs, painting of structural steel, and a new waterproof membrane. Renovation of the garage began on April 23 and is now scheduled to conclude by the end of 2019.

The supplemental appropriation is needed to remedy issues involving further deterioration of the structural steel and concrete in the garage. The cost of these repairs total \$1,490,000. The supplemental will also add \$500,000 to address repairs in all 5 garage stairwells. The northeast stairwell at Jefferson Street was recently closed due to structural concerns, but is planned to reopen this summer.

# Council staff recommends approval of this supplemental appropriation.

#### Background

- Section 307 of the Montgomery County Charter provides that any supplemental appropriation shall be recommended by the County Executive who shall specify the source of funds to finance it. The Council shall hold a public hearing on each proposed supplemental appropriation after at least one week's notice. A supplemental appropriation that would comply with, avail the County of, or put into effect a grant or a Federal, State or County law or regulation, or one that is approved after January 1 of any fiscal year, requires an affirmative vote of five Councilmembers. A supplemental appropriation for any other purpose that is approved before January 1 of any fiscal year requires an affirmative vote of six Councilmembers. The Council may, in a single action, approve more than one supplemental appropriation. The Executive may disapprove or reduce a supplemental appropriation, and the Council may reapprove the appropriation, as if it were an item in the annual budget.
- 2. The County Executive recommends the following capital project appropriation increases:

#### PROJECT DESCRIPTION

The project provides for the design and construction of repairs to the Council Office Building Garage (COBG). Repairs include, but are not limited to, concrete deck, structural steel, drains, post-tensioned concrete tendons, curbs, painting of structural steel, and a new waterproof membrane. The project will be completed in phases in order to keep the garage open in continuous operation. Each phase will require closing approximately 100 parking spaces for construction.

#### LOCATION

Rockville Core

#### **ESTIMATED SCHEDULE**

The project is expected to be finished in the summer of 2019.



## **PROJECT JUSTIFICATION**

Montgomery County Department of General Services contracted with an independent consultant to assess the condition of the COB garage. The Council Office Building Parking Garage Condition Assessment dated August 10, 2015 provides recommendations for various repairs.

#### **DISCLOSURES**

A pedestrian impact analysis has been completed for this project.

#### COORDINATION

County Council, Department of Technology Services, Department of Police, Department of General Services, Department of Transportation, Department of Fire Rescue Services, Office of Management and Budget, City of Rockville, and Montgomery County Circuit Court

#### **COST CHANGE**

The cost increase is necessary due to the need to remedy unanticipated problems with the steel, concrete and stairwells.
