SUBJECT: Update: Crime Statistics

PURPOSE: To receive a briefing.

Today the Committee will receive a comparative look at crime statistics for the County and similar jurisdictions. Acting Assistant Chief Dinesh Patil and other police staff are expected to brief the Committee.

#### **OVERVIEW**

Over the past several years, the FBI has been transitioning its Uniform Crime Reports (UCR) from its Summary Reporting System (SRS) to its new National Incident-Based Reporting System (NIBRS). Under the SRS methodology, data is divided into Part I and Part II crimes. Only the most serious charge during each offense is reported. NIBRS allows for a much more comprehensive collection of crime data. While NIBRS reports are similarly divided into Group A and Group B crimes, each category captures many more data elements, such as incident, offenses, victims, known offenders, and arrestees. Consequently, it is more difficult to provide comparative data between SRS and NIBRS reporting.

The Committee has requested comparative data with neighboring jurisdictions. MCPD advises that while it began reporting under NIBRS in 2017, other jurisdictions are at different points of transition to the new methodology. Fairfax County began reporting data in NIBRS in 2010. Prince George's County began reporting data in 2018. Baltimore County continues to report crime statistics under the older UCR SRS system. Further, not all counties report crime data from all their municipalities. For these reasons, these comparisons should be viewed with caution, as they are not always uniform in nature.

### MONTGOMERY COUNTY DATA

An overview of Montgomery County crime is provided on ©2. Total crime is down 7.3% over the past three years, although certain crimes have seen increases during the same time period. Homicides have increased over the past three years. While the data presented show a

three-year snapshot, it is important to note that the County hit a high of 30 homicides in 2015. While this chart shows a 25% increase in homicides from 2016 to 2018, it is still a significant decrease from 2015, and is more reflective of the County's 10-year average.

Rape offenses have increased by 64% over the past three years. This reflects an increase from 211 in 2016 to 346 in 2018. MCPD's annual report on crime states that the number of rapes reported in 2018 increased 27.8% from 2017 and has been steadily increasing over the last four years. The number of rapes reported in 2015 rose sharply and was primarily attributed to the FBI's rape definition change, which the state of Maryland implemented in 2015.<sup>1</sup>

Aggravated Assault offenses have also increased by 5.1% over the past three years, from 741 in 2016 to 779 in 2018. Other crimes, such as robbery, burglary, larceny, and motor vehicle theft have dropped significantly. Most significant is the decrease in Burglary offenses, which fell by more than 25% over the past three years, from 1,949 in 2016 to 1,450 in 2018.

## **COMPARISONS TO OTHER COUNTIES**

On ©4, MCPD provides comparative data among Montgomery, Baltimore, Prince George's, and Fairfax Counties. These counties were chosen because they are relatively similar in size to Montgomery County. For the most recent year provided, 2018, the following charge reflects crime data for each county.

## POTENTIAL DISCUSSION QUESTIONS

- 1. Homicides have increased by 25% in the past three years, although the total for 2018 was 20, which is significantly lower than the County's high of 30 in 2015. In prior years, a significant proportion of the homicides were gang-related. What is the composition of the underlying causes of the homicides (e.g. domestic, drug-related, gang-related)? How has that changed over time?
- 2. How does 2019 year-to-date crime data compare to 2018? Particularly for homicide and rape offenses?
- 3. MCPD advises that recent data provided to Council for sex offense statistics were reported differently than what is reflected in this update. Please explain the difference?
- 4. Historically, most rape cases have been committed by someone the victim knows, rather than a stranger. Has this trend held true into 2018?
- 5. Council has received several inquiries about crime statistics broken down by immigration status. Why are those statistics not available?
- 6. What can the drop in burglary incidents be attributed to?
- 7. Theft from vehicles has been an ongoing problem in the County. According to the 2018 Annual Crime Report, these types of larcenies decreased from 4,985 in 2017 to 3,912 in 2018, a reduction of 22%. Does this reflect better public information campaigns to get people to lock their doors?

The MCPD began reporting under the National Incident Based Reporting System (NIBRS) in 2017. This data, which was pulled from our internal dashboard on September 25, 2019, contains all the offenses that occurred in Montgomery County, including Rockville, Gaithersburg, and Takoma Park. Please note that the dashboard updates and maintains these statistics in "real time", whereas data that have been published previously by the MCPD and/or submitted to the Maryland State Police (under the UCR program rules) is only a "snapshot" of the offense data at a particular point in time.

According to the most recent data from the U.S. Census Bureau, the population in Montgomery County has grown at a slightly faster rate than the other three counties, although Fairfax County still has approximately 100,000 more people than Montgomery County. When this is put into perspective, crime rate per capita statistics for 2018 indicate that Fairfax County would be considered the safest county, followed by Montgomery County then Prince George's County, which have similar crime rates per capita (note: this can be attributed to the absence of municipality offense data in the statistics for Prince George's County).

## NATIONAL INCIDENT-BASED REPORTING SYSTEM

In 2016 MCPD began to participate in the National Incident-Based Reporting System (NIBRS). While still providing Uniform Crime Report Summary data to the State of Maryland, MCPD also provides NIBRS data to the FBI.

NIBRS crime reporting captures each reportable crime vs the UCR Summary that captured the highest crime (hierarchy rule).

Historically MCPD has provided numbers related to the offense of rape, based on the <u>date</u> the <u>incident was reported</u>. NIBRS rape reporting is based on the date the <u>incident occurred</u>. Rape statistics previously reported by the MCPD will appear higher than the numbers in this package. As an example, if a victim came forward in 2019 to report a rape that occurred in 2016, that event would be allocated to 2016, not 2019. MCPD's reporting practice in recent years would have attributed that event to 2019.

To be consistent with NIBRS and regional and national law enforcement agencies, the numbers provided in this document are consistent with NIBRS incident date. This will show as lower compared to the number of events that reflect the date the incident was reported. MCPD will maintain both dates but will move forward with being consistent with NIBRS reporting.
