SUBJECT: FY21 Operating Budget Follow-up: "DD Supplement"

PURPOSE: Follow-up on Additional Funds for Additional Eligible Service Providers

This item is a targeted follow-up to the Council's FY21 budget actions that moved forward under a continuity of services process which, at the time, did not provide an opportunity to increase the total amount of funding for the supplement paid to providers of direct services to developmentally disabled persons, referred to as the "DD Supplement."

Council staff recommendation

Recommend the Council approve a special appropriation in the amount of \$371,761 to the Department of Health and Human Services to provide the re-estimated continuity of services budget for the DD Supplement for all eligible service providers. The source of funds is General Fund Reserves.

Background

Each year, Montgomery County provides a local payment to providers of direct services to developmentally disabled persons. Due to the COVID19 health crisis, the Council's FY21 Operating Budget process approved funding levels, with only a very few exceptions, at the FY20 level to provide a continuity of service. The Council acknowledged that it would need to revisit and adjust certain items after the original approval of the budget.

The FY21 budget includes over \$17.56 million for this supplement, the same amount that was approved for FY20. As is longstanding practice, the Council included a budget provision in its County Government Operating Budget Resolution. The following is the provision that was included:

This resolution appropriates \$17,562,175 to the Department of Health and Human Services to provide a payment to organizations providing direct services to clients of residential, community supported living arrangements, day habilitation, or supportive employment provided through the Developmental Disabilities Administration. In order to receive this payment, an organization must provide any documentation requested by the Department of Health and Human Services and the organization must be in compliance with the Montgomery County Minimum Wage law. The Council intends to review the need for additional support for these organizations during FY 2021. Section G of this resolution includes entities eligible to receive this non-competitive payment.

The excerpt from Section G is attached so the Committee can see the breath of providers serving County residents. Included in this listing for FY21 are six organizations providing services that were not included in FY20. They are: Latter Rain, Living Hope, Pool of Bethesda, Renoxx, SunRise, and Unified Community Connections.

During the Council's May budget worksession, Council staff raised the issue of additional funding needed to account for disbursement of the total amount over a larger number of organizations. The method used for many years for disbursement of the total amount of County funding has been to look at the total amount of State revenues received by eligible organizations, determine the percentage of total funds they receive and then award the same percentage of County funding. At the May worksession, Council staff included an estimate of an additional \$240,000 to accommodate the six new providers. Since that session, DHHS has received updated information on State revenues and has revised the amount needed to \$371,761. It is this revised amount that will provide a more accurate continuity of service budget.

Recovery Planning and Continued work on the DD Supplement

The Department of Health and Human Services' Recovery Planning Structure includes a team for Aging and Disability Services. There are subgroups, once of which is Provider Sustainability. The subgroups are to provide a report by the end of June. As their work is just beginning it is not known what recommendations will be made.

Council staff suggests that the HHS Committee allow this team to complete its work and then schedule a discussion in July on the recommendations. At that time, the Committee can provide guidance on how to continue the work with both the providers on services to developmentally disabled persons as well as Adult Medical Daycare on the appropriate structure and level of local funding support for these organizations both for specific response to the COVID19 health crisis and ongoing local supports, including a recommendation for FY22.
