Overview

DOCR's recommended FY23-28 CIP has four projects at a cost of \$78.8 million over the next six years. This is an increase of \$73.4 million over the FY21-26 Amended CIP of \$5.5 million. The change is primarily due to the addition of design and construction of the Criminal Justice Complex project and the inclusion of two new projects: the MCCF Refresh project and the MCCF and MCDC wi-fi project.

Notable Issues for Committee Consideration

- The CJC project is newly-funded this year, after many different design iterations and funding delays. The <u>Restoration Center</u> concept is split off into a stand-alone project on the same Seven Locks Road site.
- The Committee may wish to receive periodic updates on the design process for the CJC.
- Additionally, the Seven Locks site is under consideration for relocating the <u>Shady Grove Bus Depot</u>. Council is developing a coordinated approach to reviewing all projects that may be located on the Seven Locks site.

Public Hearing Testimony

To date, Council has not received any public hearing testimony.

Individual Projects

Criminal Justice Complex (\$78.661 million) (P421100)

History: As part of the 1995 decision to operate a two-jail system, there was agreement that the Montgomery County Detention Center (MCDC) in Rockville would be renovated for continued use. In addition to serving as a jail for up to about 200 short-term inmates, MCDC would be the location for the intake and release of all inmates, the Central Processing Unit, evaluation for pre-trial services, medical and mental health assessments, the Montgomery County Police Department's Warrant and Fugitive section, centralized records and storage of inmates' personal items, and DOCR departmental training. At one time (FY07-11) there had been more than \$38 million programmed for the renovation of this building.

In June 2008, the Public Safety Committee was told that given the continued increasing cost estimates for the renovation, its age, and because the ongoing work related to the Property Use Study/Smart Growth Initiative had looked at future use of County-owned property on Seven Locks Road, the Executive had convened a work group and hired a consultant to look at different options for how to provide for the criminal justice programs that were to be housed in the renovated MCDC.

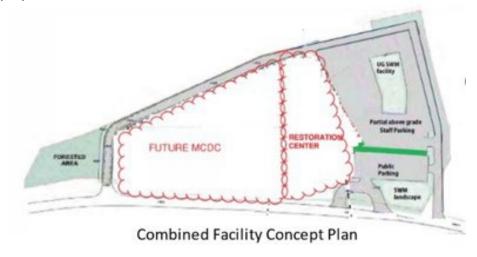
Based on a comprehensive assessment conducted by the independent consultant, Public Financial Management, Inc., it was determined that the renovation of the existing structure was not cost effective due to the need for significant capital expenditures, life cycle costs, and continued maintenance of aging building systems. As a result of the assessment, the Detention Center Reuse project was closed out.

In October 2008, the County Executive informed the Council that he recommended a new Criminal Justice Complex be built at the end of Seven Locks Road (current site of the former 1st District Police Station). The site was to have become available when 1D was relocated to the Public Safety Headquarters at Edison Park Drive. The former district station on Seven Locks is currently used as flex space. The CJC project was added to the Capital Budget in FY11. At that time, the estimated cost of the new CJC was \$65 million. The approved FY19-24 CIP contained \$1.368 million in both FY20 and FY21 as placeholders while the County Executive determined whether outside support was available and enough to assist in funding the project. The project would have included space for diversion and deflection, assessing, and providing paths other than arrest for individuals with substance abuse or mental health disorders. At that time, the Executive estimated the total cost at \$120 million.

The approved FY21-26 PDF included \$684,000 as a placeholder while Executive staff reviewed the original concept to meet current and future deflection needs at a scaled-down cost. The Executive was also exploring whether the deflection and diversion services might be better situated in a different part of the County where needs were greater.

Restoration Center: Over the past two years, the original deflection and diversion model has evolved to become a Health and Human Services (HHS)-based Restoration Center, which will be housed at the Seven Locks site. It has been designated as its own <u>capital project</u>, and initially will be a stand-alone building on the property.

Current Project: The designation of a separate Restoration Center allows the CJC to be scaled down to address its original functions of Central Processing/Detention to support processing new arrestees and detaining remanded individuals for up to 72 hours. Other uses include District Court Commissioners; Department of Health and Human Services Mental Health Assessment and Placement Unit; Pre-Trial Services Assessment Unit; Public Defenders Unit; and the Police Warrants and Fugitive Unit. The new projected cost is \$78.661 million, of which, the County assumes 50% will be funded with matching State aid. Design is programmed to begin in the Fall of 2023. Construction is expected to begin in Spring of 2026. Below are two illustrations of the proposed Seven Locks site.





Now that the project has been funded for design and construction, it would be helpful for the Committee to better understand the proposed design process to meet both the needs of arrestees and staff as well as the community. Almost a decade ago, DOCR contracted with an outside consultant to produce the 2014 Master Facilities Confinement Study, which sought to project bedspace and other operational space needs through 2035. This study attempted to project changes in County approaches to deflection, and account for other potential systemic changes, both internal and external to corrections. The Committee should understand whether the County plans to use this study as a basis for jail design, or whether there is a need for an updated approach. Council staff recommends that the Committee periodically meet with DOCR and DGS to stay updated on the design process.

Montgomery County Detention Center Partial Demolition and Renovation (\$4.791 million) (P422102)

History: The original facility was built in 1961, although the high-rise tower and other modular units were constructed later. A replacement for this building has been in the CIP since FY97 and was finally closed out in FY11. Over the past 10 years, significant stabilization efforts have been performed, including a new Central Processing Unit in 2013-2014. The new layout improved security and workflow while processing arrestees for intake. It provided a new area for the District Court Commissioners and Public Defenders, and improved layout and security at a new sally port. It also included some roofing renovation and other system stabilization.

Current Project: Since the CJC had been delayed, this project was added to the CIP in FY21. This project will renovate certain areas of the facility and demolish vacant space including the High Rise Tower, five vacant modular units and a CIU pod. Construction started in mid-2021 and is scheduled for completion in Fall 2022. Funding has moved into the six-year period due to modest project delays.

Montgomery County Correctional Facility and Community Corrections Wi-Fi Project (\$0.936 million)

(P422301)

Current Project: This new project provides for the design and implementation of wireless internet at MCCF and Community Corrections (CC). The project also supports installation of wireless internet upgrades at MCDC. It will provide MCCF network switches and install wi-fi throughout the MCCF facility including the common areas of housing pods, medical suite, and administrative areas. Wi-fi will also be installed throughout the CC facility. Implementing Wi-Fi at MCCF and CC will enhance implementation of the new Electronic Health Records (EHR) system, improve work productivity, and provide advanced learning technology for the staff and inmate population.

The Executive advises that the lack of wireless internet at MCCF and CC limits the implementation of the EHR system, restricts how staff can work and train, limits inmate programming, and reduces efficiencies. Without wireless internet, employees must use network cables to connect to the internet and access files where a network cable is available. Implementation in the MCCF housing areas is programmed for FY23; MCCF administrative areas and MCDC wi-fi upgrades are programmed for FY24; CC is programmed for FY25.

Montgomery County Correctional Facility Refresh (\$4 million) (P422302)

This facility was built in 2003 has had limited capital improvements despite significant wear and tear. The project provides for the planning of an MCCF Refresh project to include medical unit modifications and remediation of clogged vents in inmate cells. Medical unit modifications include moving a nurse and correctional officer station to improve sight lines, increase female inmate capacity, increase inmate holding cell space, and other adjustments needed to accommodate implementation of the new State mandated Medication Assisted Treatment program. The project also provides for paint throughout the facility and carpet replacement in administrative areas. Additional funds to design and construct these improvements will be required in a future CIP. The proposed improvements are required to maintain the facility in good repair and address operational needs. Medical modifications are required to provide a safe and secure environment for inmates receiving medical services to include adequate medical and security supervision. Medical modifications are also required to accommodate new treatment requirements associated with the State mandated Medication Assisted Treatment program. Vent remediation is required to provide adequate air quality for the inmate population. Initial planning of medical unit modifications and vent remediation will begin in FY23. Funding to support medical unit

modification and vent remediation implementation is programmed in FY24 and FY25. Repainting the facility and carpeting is programmed for FY26 and FY27.

Council Staff Recommendations: Council staff recommends approval as submitted by the Executive. Council staff also recommends that the Committee receive periodic updates on the design phase of the new Criminal Justice Complex.

PROGRAM DESCRIPTION AND OBJECTIVES

The mission of the Department of Correction and Rehabilitation (DOCR) is to protect and serve the residents of Montgomery County and the general public by providing progressive and comprehensive correctional rehabilitative services. These functions are achieved through the employment of well managed and effective correctional programs including: the use of pre-trial supervision; secure incarceration; community treatment; reintegration programs; highly accountable security methods and procedures in each operating unit and program; and effective and progressive administration and management oversight. The Department's goals are:

- To protect the public and the residents of Montgomery County by providing a wide range of constructive professional correctional services for pre-trial and convicted detainees;
- To ensure the safety and welfare of staff and detainees;
- To reduce the rate of reincarceration by providing offenders with the opportunity for self-improvement and the inner resources necessary to make a successful adjustment within the community;
- To attain an exemplary correctional system and to continue to develop and maintain a professional correctional staff; and
- To meet the future correction and rehabilitation needs of the County by means of effective planning and responsible fiscal and resource management.

The Department uses several facilities to achieve these goals: the Montgomery County Correctional Facility (MCCF), the Montgomery County Detention Center (MCDC), and Community Corrections.

HIGHLIGHTS

- Provide funding to design and construct a new Criminal Justice Complex (CJC) on the site of the former District One Police
 Station located at the north end of Seven Locks Road. The new facility will include a Central Processing/Detention component
 to support processing new arrestees and detaining remanded individuals for up to 72 hours. The facility will be constructed in
 close proximity to the proposed Restoration Center to maximize diversion and deflection opportunities.
- Prior to constructing a new Criminal Justice Complex, construct modifications to the Montgomery County Detention Center (MCDC) to include consolidating operations within the structural footprint and demolishing dilapidated structures. Renovation and restoration of specific areas of the building is included.
- Plan and install wireless internet throughout Montgomery County Correctional Facility (MCCF) and Community Corrections
 (CC) and perform wireless upgrades at the Montgomery County Detention Center. Providing wireless internet capabilities in
 these facilities will enhance the implementation of the electronic health records system, improve work productivity, and provide
 opportunities for advanced learning technologies for the staff and inmate populations.
- Provide for the planning of a Montgomery County Correctional Facility Refresh project to include medical unit modifications
 and remediation of clogged vents in inmate cells to address health and life safety needs. The project also provides for paint and
 carpet replacement throughout the facility.

CAPITAL PROGRAM REVIEW

The Recommended FY23-28 Capital Improvements Program for Correction and Rehabilitation is comprised of four projects totaling \$78.8 million. This represents a \$73.4 million or 1,340.0 percent increase from the Amended FY21-26 Program of \$5.5 million. The increase is due to the addition of design and construction of the CJC project and the inclusion of two new projects: the MCCF Refresh project and the MCCF and CC Wi-Fi project.

PROJECT DESCRIPTION

This project provides for the design and construction of a new Criminal Justice Complex (CJC) on the site of the former District One Police Station located at the north end of Seven Locks Road. The new facility will include a Central Processing/Detention component to support processing new arrestees and detaining remanded individuals for up to 72 hours. Other uses include: District Court Commissioners; Department of Health and Human Services Mental Health Assessment and Placement Unit; Pre-Trial Services Assessment Unit; Public Defenders Unit; and the Police Warrants and Fugitive Unit. The project incorporates technical requirements from the Detention Center Reuse project in addition to updated space requirements developed by an interagency working group. The facility will be constructed in close proximity to the proposed Restoration Center to maximize diversion and deflection opportunities.

LOCATION

1451 Seven Locks Road, Rockville, Maryland

ESTIMATED SCHEDULE

Design is programmed to begin in the Fall of 2023. Construction is expected to begin in Spring of 2026.

COST CHANGE

The project scope has been updated to include the cost of design and construction.

PROJECT JUSTIFICATION

This project is consistent with Council Resolution 13-356 passed by the County Council on December 5, 1995 which approved two jail facilities at two locations - Rockville and Clarksburg - as priority public safety uses. The renovation of the existing Montgomery County Detention Center facility (Detention Center Reuse Project No. 429755) was determined not to be cost effective due to the need for significant capital expenditures, life cycle costs, and continued maintenance as a result of aging systems. It was determined to be cost effective to replace the Montgomery County Detention Center with a new Criminal Justice Complex facility.

OTHER

Racial Equity Impact Assessment: When considering the location and design of building(s) that would offer pre-booking diversion services, the Department of Correction and Rehabilitation, along with other stakeholder agencies, will conduct a Racial Equity Impact Assessment that looks at the following:

- What is the proposal and what is it seeking to accomplish?
- How might the proposal impact communities and people of color differently?
- What do the data tell us?
- Who is impacted by the proposal?
- What are the recommended strategies to address unintended consequences and adverse impacts to promote racial equity with this proposal?

FISCAL NOTE

The project assumes that fifty percent of project expenditures will be supported by State Aid.

DISCLOSURES

A pedestrian impact analysis has been completed for this project. The County Executive asserts that this project conforms to the requirement of relevant local plans, as required by the Maryland Economic Growth, Resource Protection and Planning Act.

ESTIMATED SCHEDULE

Implementation in the MCCF housing areas is programmed for FY23; MCCF administrative areas and MCDC wi-fi upgrades are programmed for FY24; CC is programmed for FY25.

PROJECT JUSTIFICATION

The lack of wireless internet at MCCF and CC limits the implementation of the EHR system, restricts how staff can work and train, limits inmate programming, and reduces efficiencies. Without wireless internet, employees must use network cables to connect to the internet and access files where a network cable is available. Voice Over Internet Protocol (VOIP) also cannot be implemented in these facilities due to the outdated technology infrastructure. Without wireless internet, EHR capabilities would be limited; providers would be required to record medical information on a mobile device for visits and medication administered in housing areas and then perform a daily data download. This delays the recording of medical information which could result in adverse health outcomes. The EHR system will be implemented in all three Department of Correction and Rehabilitation facilities (MCCF, CC, and MCDC).

PROJECT DESCRIPTION

This project provides for the planning, design, and renovation/modification of the Montgomery County Detention Center (MCDC) for use primarily as a short-term holding and central processing facility. The original building was built in 1961 with the High Rise/Tower and other modular units constructed thereafter. The project provides for demolition of dilapidated out of operation structures including

demolition of the High Rise/Tower, five vacant modular units and the CIU pod which is currently used by HHS. Prior to demolition, the existing utilities will be rerouted, and a new utility structure will be built. HHS will be relocated from the CIU pod to a temporary location in the occupied building while renovation of their final location is completed. Renovation of other select areas of the building is included. The work will be done in phases due to the complexity of the project and the need to keep the main building operational throughout the project.

LOCATION

ESTIMATED SCHEDULE

Construction started in mid-2021 and is scheduled for completion in Fall 2022. Funding has moved into the six-year period due to modest project delays.

PROJECT JUSTIFICATION

Council Resolution 13-356, passed by the Montgomery County Council in 1995, approved a two-jail system which includes the Montgomery County Correctional Facility (MCCF) located in Boyds and the Montgomery County Detention Center (MCDC) in Rockville. The current MCDC was the designated location for the intake and release of all inmates. Functions included the Central Processing Unit (CPU); the Maryland County District Court Commissioners; evaluation for pre-trial services, medical and mental health assessments; centralized records and storage; and DOCR training. The facility also provides beds for housing inmates during intake process. After many years of service, the building is no longer in good repair and does not meet all the current State and County requirements. To meet the requirements of the Council Resolution, MCDC needs to be replaced or renovated sufficiently in order to operate fully until a future new Criminal Justice Center can be constructed in its place. To provide an immediate response to these issues the project proposes a limited renovation of the buildings remaining after demolition of unused structures. As part of the renovation, and in order to continue to provide these services, specific changes will be implemented to meet current State and County requirements. In addition, a general refresh of spaces is needed to provide a conducive workspace for the staff for the immediate future. Demolition of five vacant modular structures and the partially occupied CIU pod will save maintenance and energy costs. Annual maintenance costs for this facility routinely reach and sometimes exceed \$100,000.
