SUBJECT: Executive Regulation 04-23: Police-Private Security Camera Incentive

Program

PURPOSE: Review and Vote on Proposed Regulation

Today, the Joint Committee will review the proposed Executive Regulation 04-23. Those expected to attend the worksession include:

Chief Marcus Jones, Montgomery County Police Department (MCPD) Lt. Dan Helton, Management Services Bureau, MCPD

Background

Last year, the Council passed Bill 14-22, which establishes a private security camera incentive program within the Montgomery County Police Department. The purpose of the program is to deter crime by incentivizing the installation of security cameras in geographic areas experiencing relatively high incidences of crime. Since the pandemic, certain types of crime have increased. In the first quarter of 2023, violent crime increased by 7% and non-violent crime increased by 3% over the same period in 2022. There is ongoing community interest in the program. Over the past year, the Council has received several calls and letters from residents seeking information on the program. The District of Columbia has a similar program.

This program permits a voluntary co-production of public safety between community members and police. While such voluntary collaboration may help improve police legitimacy in the community, the use of surveillance technology may also raise privacy concerns. At the public hearing on the bill, the Council received testimony expressing those concerns, as well as several recommendations for minimizing unnecessary or intrusive recording. Several of the recommendations have been adopted in the bill and regulation, including businesses posting clear

notice of cameras, and all applicants positioning cameras so that they do not unnecessarily view and record someone else's private property.

Under the program, an individual, business, or nonprofit organization may apply to MCPD to receive a voucher or rebate to offset the cost of a security camera on the applicant's property. The property must be within a "priority area" designated by the Police Chief.

The bill defines "priority area" as "one or more police districts identified by the Chief as needing additional security cameras based upon public safety indicators, including crime levels." The Chief mast promulgate regulations to carry out the program. Additionally, the Chief is required to report to the Council annually regarding the implementation of the program, including the number and amount of rebates and vouchers awarded, and the efficacy of the program.

The bill requires regulations to address:

- (1) the methodology used to identify a priority area;
- (2) the permissible collection, dissemination, use, and disposal of images recorded by a security camera purchased under the program; and
- (3) minimum standards for security cameras purchased under the program.

Proposed Executive Regulation 04-23

The proposed regulation implements the private security camera rebate program established by Bill 14-22. The regulation was advertised in the February 2023 Register and no comments were received. It was introduced at Council on June 13, 2023, and may be approved under Method (2). Under Method (2) if the Council does not approve, disapprove, or extend the time for consideration within 60 calendar days, the regulation automatically takes effect.

Individuals, businesses, or nonprofit organizations may participate in the program. Applicants must register online, at which time they will be able to determine whether they live or conduct business in a priority area. Applicants must purchase and install their cameras before applying for the rebate.

Applicants agree in writing that the security camera must not be used for the purpose of recording private property not owned by the applicant, and if the applicant is a business or a non-profit organization, the applicant agrees in writing to post notice prominently to alert visitors of the existence of the security camera(s).

The Department will reimburse eligible applications up to \$250 for one camera per qualifying individual applicant, and up to \$1,250 for five cameras for qualifying business or nonprofit applicants. Rebates may not exceed the actual cost of the cameras. The rebate program is subject to appropriation. In FY24, the Executive recommended \$511,000 to fund the first year of the program. The Council approved \$255,000 for the program. The funding could provide reimbursement for approximately 1,020 cameras.

As required by the statute, the proposed regulation specifies:

- 1) The methodology used to identify a priority area:
 - "One or more police districts identified by the Police Chief as needing additional security cameras based upon public safety indicators, including crime levels."
- 2) The permissible collection, dissemination, use and disposal of the images recorded by a security camera purchased under the program:
 - "The Department will not automatically have access to video from cameras purchased under this program. The Department may have access to live or recorded video with the express permission of the applicant or through other legal mechanism."
 - "The collection, dissemination, and use of video by the Department will be for official law enforcement purposes. Efforts will be made to ensure anonymity of the Applicant."
- 3) Minimum standards for security cameras purchased under the program.

"Security camera systems shall meet minimum technical and video quality specifications published on the Department's application website and must retain video footage for at least seven (7) days. Security camera systems shall be installed on the exterior of a building and shall be weatherproof."

Program Implementation

The Department expects to start the program this summer. It has the staffing and resources to build a web-based application system. Once the applicant's purchase is verified by the Police Department, the Department of Finance will issue the rebate.

Potential Discussion Questions

- 1. The proposed regulation does not explicitly state the Department's video disposal policy. Is it the same as existing evidence protocols? If not, what is it, and will it be specified in departmental policy?
- 2. What safety protocols will be in place to prohibit unauthorized access or use of video footage?
- 3. The statute defines a priority area as one or more police districts identified by the Chief as needing additional security cameras based upon public safety indicators, including crime levels. When will the Department specify eligible police districts?
- 4. Are there plans to provide online information and the application process in more than one language?
- 5. Will there be a contact phone number or email available for public questions about the program?
- 6. State and federal aid may be available to help fund the program. Has the Department explored any grant funding opportunities? Would this program be eligible for FEMA reimbursement funding?
- 7. How does the Department plan to measure success?

SUBJECT: Executive Regulation 04-23: Police-Private Security Camera Incentive Program

Bill 14-22 was enacted by the County Council on July 26, 2022 to establish a private security camera incentive program within the Montgomery County Police Department. This new law specifies the eligibility rules and administrative requirements for the program. Executive Regulation 04-23 sets the implementation process of the police-private security camera incentive program for qualifying residents, businesses, and nonprofits. It may be adopted under Method (2).

Enclosed for your review is the draft Executive Regulation 04-23, Police – Private Security Camera Incentive Program as posted in the February 2023 edition of the County Register. The regulation establishes the appropriate definitions, general provisions, application, priority areas, security camera specification, verification of security camera installation, and rebate issuance necessary for successful program implementation.

Also enclosed is a revised version of the regulation incorporating minor punctuation changes and grammatical corrections, as well as adding clarifying language in Section B (2)(a)(b), (5), and (6). None of these modifications resulted in any material change to the Regulation as posted in the County Register, and no public comments were received during the comment period.

Police - Private Security Camera Incentive Program

Regulation Summary

This regulation implements the private security camera incentive program for qualifying individuals and businesses. The executive regulation establishes a \$250 maximum reimbursement for the installation of a camera subject to appropriation and a limit of one camera per property address. The regulation also establishes an application process, identifies a verification process for installation, and creates other requirements for program participation.

Fiscal Impact Summary

Expenditures under the regulation are subject to Council appropriation for the program. The FY24 Council Approved Budget includes \$255,000 to support the program. Demand for the program is contingent on the number of eligible individuals, businesses, and non-profit organizations, and future years reflect full implementation. While the Department may seek Federal or State funding to support the program, revenues are not expected to be impacted at this time.

Expenditures for the next six years will depend on Council appropriation. The FY24 Council Approved Budget includes \$255,000 to support half-year implementation of the program. Assuming full-year implementation is provided in FY25 and beyond, expenditures increase to \$501,000 in FY25 and beyond. This funding level includes \$10,000 in year one for web development to create the online form for submission tracking and recording payments and \$1,000 for advertising in the out-years.

Fiscal Impact Analysis

Should the funding level provided for the incentives be significantly higher than the amount assumed in this statement, then there would likely be additional administrative and information technology costs associated with implementing the program.

The executive regulation is not expected to impact County revenues.

Staff Impact

Under the assumption of a limited appropriation for incentives, management and administration of this program can be absorbed into the existing MCPD staffing complement. However, if the amount provided for incentives is significantly higher than what is assumed in this analysis, new software and significant staffing increases could be needed.
