PURPOSE: Action on Bill – Council roll call vote required

Government Operations and Fiscal Policy Committee recommendation (3-0): enact Bill 28-18 as introduced.

Bill 28-18, Boards, Committees, and Commissions - Amendments, sponsored by Lead Sponsor Council President Riemer at the request of the County Executive, was introduced on July 17, 2018. A public hearing was held on September 18 at which there were no speakers. The Executive submitted written testimony, which is on ©21. The Government Operations and Fiscal Policy Committee held a worksession on Bill 28-18 on September 24.

Bill 28-18 would reduce the membership of the Cable and Communications Advisory Committee from 15 members to 9 members, increase the number of veteran representatives on the Commission on Veterans affairs and remove the Director of the Department of Economic Development from the Commission, and change the name of the Committee on Hate/Violence to the Committee Against Hate Violence. The Executive originally transmitted 3 separate bills, but agreed to consolidate the bills into 1 omnibus bill.

The County Council for Montgomery County, Maryland approves the following Act:

Sec 1. Sections 8A-30, 24-61, and 27-63 is amended as follows:

8A-30. Cable and Communications Advisory Committee.

* * *

(c) The Advisory Committee must have [15] 9 voting members appointed by the Executive and confirmed by the Council for 3-year terms. The members should broadly represent technology areas.

(d) The [membership must include] Executive must appoint one representative selected by the Montgomery County Chapter of the Maryland Municipal League[;], one representative selected by the City of Rockville[;], and one representative selected by the City of Takoma Park. However, if any of these organizations do not provide a representative, the representative may be selected from the public at large.

(e) The Executive must appoint 6 members selected from the public at large.

(f) The members annually must elect the chairperson and vice chairperson of the Committee. A person must not serve more than 2 consecutive terms as chairperson.

[(e)] (g) Members are subject to Chapter 19A.

Sec. 24-61. Commission on Veterans Affairs.

* * *

(c) *Composition; Term.*

(1) The Commission has 16 voting members.

(2) The Executive should appoint [8] 9 members who are veterans and may be a member of a veterans group, such as:

(A) Vietnam Veterans of America;

(B) American Veterans (AMVETS);

(C) Disabled American Veterans;

(D) Veterans of Foreign Wars;

(E) Women Veterans of America;

(F) American Legion; or

(G) Military Order of the Purple Heart.

(3) The Executive must appoint 4 members to represent the general public.

(4) The Executive must designate the following ex officio members:

(A) the Director of the Department of Health and Human Services, or the Director's designee;

(B) [the Director of the Department of Economic Development, or the Director's designee;

[(C)] the County Executive or the Executive's designee; and

[(D)] (C) the President of Montgomery College or the President's designee.

* * *

27-63. Committee [on] Against Hate/Violence.

(a) *Members.* The County Executive must appoint, subject to confirmation by the County Council, a Committee [on] Against Hate/Violence. The Committee consists of 15 voting members and 6 ex-officio nonvoting members. Each voting member must, when appointed, reside in the County.

SUBJECT: Bill to Change the Membership of the Cable and Communications
Advisory Committee

I am submitting, for the Council's consideration, a bill that would reduce the number of members on the Cable and Communications Advisory Committee, and make the City of Rockville, City of Takoma Park and Maryland Municipal League positions flexible so that if they cannot be filled, the positions may be filled by members of the public.

The changes are necessary because it has been difficult to attract new members of the Commission, and the City of Rockville, City of Takoma Park and the Maryland Municipal League are often unable to provide representatives, leaving the Commission low on membership and unable to have a quorum and, therefore, unable to vote on issues.

It will be easier to fill positions on a Commission with fewer members, and easier to fill the City of Rockville, City of Takoma Park and Maryland Municipal League positions with public members if no representatives are provided.

There will be no fiscal or economic impact to the County if these changes are approved.

STATEMENT OF COUNTY EXECUTIVE ISIAH LEGGETT ON EXPEDITED BILL 28-18, BOARDS, COMMITTEES, AND COMMISSIONS – AMENDMENTS

September 18, 2018

Expedited Bill 28-18 was introduced to make several primarily technical changes to three board, committees and commissions.

First, Bill 28-18 will reduce the membership of the Cable and Communications Advisory Committee from 15 members to 9 members. This change is necessary because changes in cable service and process makes 15 members unnecessary and because it has been difficult to attract new members of the Commission. The City of Rockville, City of Takoma Park and the Maryland Municipal League are often unable to provide representatives, leaving the Commission low on membership and unable to have a quorum and unable to vote on issues. It will be easier to fill positions on a Commission with fewer members, and easier to fill the City of Rockville, City of Takoma Park and Maryland Municipal League positions with public members if no representatives are provided. A streamlined committee can more easily attain full membership and maintain a quorum.

The bill also seeks to change the membership composition of the Commission on Veterans Affairs. It reduces the number of *ex officio* positions by removing the "Director of the Department of Economic Development, or the Director's designee" because the Department of Economic Development was abolished. The bill would also add one additional veteran position to the Commission.

Finally, this bill changes the name of the Committee on Hate/Violence to the Committee Against Hate/ Violence to more accurately reflect the mission and duties of the Committee.

I respectfully request the Council's favorable consideration of the bill.
