#### **BOARD OF APPEALS**

<u>Created:</u> Montgomery County Code, Sections 2-108 through Section 2-116.

**Term:** Four years.

**Purpose:** Exercise functions and powers of regional district as such functions and

powers are prescribed in the Maryland-Washington Regional District Act (as revised and included in the new Land Use Article) to extent that such functions and powers are not vested in another administrative officer or agency. Hear and decide: all petitions for variances; and administrative appeals, including all appeals taken under the Building Code; all appeals concerning licenses for hospitals, sanitariums, nursing homes and care homes; and all appeals concerning licenses for private educational institutions. Also hear and decide appeals concerning: special exceptions decided by the Hearing Examiner, orders directing removal of diseased trees, orders concerning restaurant permits, licenses for places of

amusement and amusement enterprises, the electrical contractors license law, and all other appeals as the Board may be authorized to hear from time

to time by law, ordinance, or resolution.

**Membership:** Five members, who must be residents of the County, are appointed by the

County Council. No more than three members shall be from the same

political party. The Chair is appointed by the Council.

**Financial Disclosure:** Public financial disclosure statements must be filed.

Chair - \$22,040; Member - \$15,595. Both receive annual cost-of-living

adjustments each December to reflect 50% of the change in the Washington

Area Consumer Price Index.

**Meetings:** Weekly hearings all day Wednesday and worksessions every other week,

additional days as necessary.

# Montgomery Council Seeks Applicants for County Board of Appeals

Deadline to Submit an Application is Friday, December 18 at 5:00 pm

ROCKVILLE, Md., November 27, 2020—The Montgomery County Council is seeking applicants for a partial term on the County Board of Appeals. The term to be filled is currently held by Katherine Freeman, who will be resigning. Her term expires in September 2021. Applications for the position must be received no later than 5 p.m. on Friday, December 18.

By law, no more than three members of the board shall be from the same political party. This position can be filled by a Democrat, a Republican, a voter who is unaffiliated with a party, or a voter who is a member of another party officially recognized by the Board of Elections.

In addition to Ms. Freeman (Democrat), current members of the Board include Chair John Pentecost (Democrat), Bruce Goldensohn (Republican), Mary Gonzales (Democrat), and Richard Melnick (Unaffiliated). Members of County Boards, Committees and Commissions may not serve on more than one such group at a time.

Members of the Board receive \$15,595 annually, with the Chair receiving \$22,040. Salaries are adjusted each December to reflect 50 percent of the change in the Washington Area Consumer Price Index.

Duties of the Board of Appeals include hearing and deciding requests for variances from development standards contained in the Zoning Ordinance; hearing appeals from certain administrative decisions rendered by County government agencies; and hearing oral argument on and deciding appeals from decisions of the Hearing Examiner on conditional uses. The Board also considers and decides requests for modifications of special exceptions.

The Board normally holds weekly hearings all day Wednesday and worksessions every other week on Wednesdays. If necessary to accommodate an extended caseload or continued hearings, the Board may schedule hearings on other weekdays. Members are expected to prepare for the hearings by reading the cases to be heard and to share the workload of drafting and editing opinions or to follow-up on investigations on specific cases. Members work approximately 15-25 hours a week.

The principal jurisdiction of the Board of Appeals does not include the municipalities of Brookeville, Poolesville, Laytonsville, Rockville, Barnesville, Gaithersburg, and Washington Grove. The Council is not precluded from appointing someone who resides in one of these municipalities, although the Council may avoid doing so.

Letters expressing interest, including a resume (no more than 4 pages in length) listing professional and civic experience, political party affiliation, home and office telephone numbers and an email address, should be addressed to: Council President, County Council Office, 100 Maryland Avenue, Rockville, Maryland 20850 or emailed to <a href="mailto:county.council@montgomerycountymd.gov">county.council@montgomerycountymd.gov</a>. Letters of application must be received no later than 5 p.m. on December 18. It is the Council's policy not to consider applications received after the deadline. After the closing date, Councilmembers will review the letters of application and select applicants to interview.

Letters of application and resumes are made public as part of the appointment process. (personal contact information is redacted). Any interviews held are open to the public and will be televised. A financial statement of assets, debts, income and family property interests will be required of all applicants. Only the appointed candidates will be required to make the financial statement available for public review.

#### SUPPLEMENTAL CAREER INFORMATION

This supplement is intended to inform the County Council of my substantial and relevant experience in business, law, real property development, management and financing and my perspective on the future.

76-80 JEFFERSON STREET CONVERSIONS. While attending NYU law school I managed several buildings including a block front on Jefferson Street in the Two Bridges area of Manhattan. Two 5 story buildings with a ground floor warehouse, loading dock, a factory, a street level restaurant and bar, and 30 loft spaces. Initially, the commercial lofts were unrentable but I saw the opportunity to create lofts for Artists in Residence by installing residential infrastructure. I managed the installation, construction and conversion process and later advocated for the passage of "Artist in Residence laws" which eventually were enacted. Lesson learned flexibility is invaluable.

The Jefferson Street properties were included in NYC's "TWO BRIDGES PLAN". A long delayed area plan for public housing. They were designated for redevelopment for 12 years many were buildings were vacant and unsaleable. I managed the eminent domain process including appraisals and achieved maximum awards. It was a graphic example of the downside of long delays caused by the Planning process which left property owners in limbo during the redevelopment process. Lesson learned - Uncertainty has a negative impact on the financial viability of property.

EMINENT DOMAIN - CONDEMNATION AWARDS. I was employed at a leading law firm specializing in eminent domain proceedings for properties affected by the demolition of the Third Avenue elevated subway line including extensive Bloomingdale holdings. I participated in certiorari appeals, including overseeing appraisals and related valuation issues. Other clients included owners of showroom, office, factory buildings in the Fashion District of New York City. I participated in sales, leasing, mortgaging, violations resolution and other property related matters representing tenants and landlords.

REAL ESTATE BROKERAGE. Returning from military service and recently married, I resumed management of the Jefferson Street properties. I obtained a real estate brokerage license and purchased and managed real property on the lower east side of NY. I also specialized in conversions, sales and rental of lofts for use as residence and studios. I hired and trained managers to convert commercial properties.

I was employed by law firms specializing in what was then called "Copyright and Show Business law" and in three years opened my office at 80 Pine Street, in NYC. My law practice was a "general" practice matters and included representing landlords, tenants, condemnations, violations, I was tangentially involved in matters involving acquisitions by the Zeckendorf interests in Freedomland, Co-op City, Kips Bay acquisition of property and conversions. I also managed a lucrative trucking facility on West 36<sup>th</sup> Street for my wife's family and a valuable pier and warehouse on the East River.

POLITICAL ACTIVITIES. NYC PLANNING BOARD. I was engaged in Reform Democratic Politics and was appointed to NYC PLANNING BOARD #8 which was in the first group of Planning Boards. We advised on many matters impacting a

a rapidly changing neighborhood including commercialization, demolition, and preservation of landmarks, parks and public amenities.

I eventually sold the bricks and mortar business converting and managing its internet business and licensing business. Along the way I co-authored a book "The Polo Primer".
