# BACKGROUND

This supplemental appropriation is needed to authorize the expenditure of Federal funds received through the CARES Act. The goal of this appropriation is to provide funds to pay for operating costs of Ride On related to the prevention, preparation for, and response to COVID-19.

The County Executive recommends a supplemental appropriation in the amount of \$30,167,124 and specifies the source of funds as Federal Aid. The Council's public hearing and action are scheduled for February 23, 2021.

- SUBJECT: Supplemental Appropriation #21-501 to the FY21 Operating Budget Montgomery County Government Department of Transportation Maryland Department of Transportation (MDOT) Transportation Assistance Grants - \$30,167,124

I am recommending a supplemental appropriation to the FY21 Operating Budget for the Department of Transportation in the amount of \$30,167,124. This appropriation will fund personnel costs for bus operators during the COVID-19 pandemic.

This increase is needed to authorize the expenditure of funds received in State Aid. These funds are being provided in the form of two separate yet related grants from MDOT with funding origins in the Coronavirus Aid, Relief and Economic Security (CARES) Act. The primary goal of these grants is to provide funds to pay for operating costs of transit systems related to the prevention, preparation for, and response to COVID-19.

I recommend that the County Council approve this supplemental appropriation in the amount of \$30,167,124 and specify the funding source as Federal Aid.

### **Background**

- 1. Section 307 of the Montgomery County Charter provides that any supplemental appropriation shall be recommended by the County Executive who shall specify the source of funds to finance it. The Council shall hold a public hearing on each proposed supplemental appropriation after at least one week's notice. A supplemental appropriation that would comply with, avail the County of, or put into effect a grant or a Federal, State or County law or regulation, or one that is approved after January 1 of any fiscal year, requires an affirmative vote of five Councilmembers. A supplemental appropriation for any other purpose that is approved before January 1 of any fiscal year requires an affirmative vote of six Councilmembers. The Council may, in a single action, approve more than one supplemental appropriation. The Executive may disapprove or reduce a supplemental appropriation, and the Council may reapprove the appropriation, as if it were an item in the annual budget.
- 2. The County Executive has requested the following FY21 Operating Budget appropriation increases for the Department of Transportation:
