Review Planning Department and Department of Parks accomplishments and work program, providing any input on work program items for the coming fiscal year.

DESCRIPTION/ISSUE

The Semi-Annual Report of the Planning Board to the Council typically occurs in the spring and fall each year. It is an opportunity for the Board to brief the Council on the accomplishments of the Parks and Planning Departments and provide an update on work program items. The Semi-Annual report is customarily provided to the Council in the form of a presentation.

SUMMARY OF KEY DISCUSSION POINTS

PARKS

The Parks Department's Semi-Annual presentation will provide information on the Department's response to COVID-19 - what's open and what remains closed, rent abatement for Park facilities, and several programming changes the Department has undertaken to adapt to the ongoing circumstances.

Parks will provide an update on several ongoing Parks capital projects and programs, including the recent opening of Josiah Henson Museum and Park, stream restoration projects, park acquisitions, Ken Gar Park improvements, the Park Visitation project, and Parks Partnerships.

In addition, the Council will be updated on Parks ongoing athletic fields work, several trail projects, and financial support for Parks from sources other than County taxes (outline attached on ©1)

PLANNING

The Planning Department's Semi-Annual presentation will include an update on the Department's almost complete Thrive Montgomery 2050 general plan update. The Plan's overarching objectives for future land use focus on economic competitiveness, racial equity and social justice (RESJ), and environmental sustainability. The Council will also be updated on Planning's Focus on Equity initiative, including training, creation of Equity Focus Areas and an Equity Opportunity Index, coordination with the Office of Legislative Oversight on RESJ Impact Statements, the Street and Parks Facilities Renaming project, Missing Middle Housing efforts in recent master plans, and Vision Zero work.

The Department will update the Council on ongoing and upcoming work program items, and provide an overview of several regulatory projects as well as statistics on development applications and community engagement (outline attached on ©2).

Planning's Semi-Annual presentation will also include their proposed FY22 work program schedule for master plans and studies. (Proposed Master Plan and Major Projects Schedule is attached on © 4.)
