Erich Seeks Applicants for Commission on Aging

County Executive Marc Elrich is seeking applicants to fill nine vacancies on the Commission on Aging (COA). Four incumbents are eligible to apply for reappointment. **Seniors and non-seniors are encouraged to apply; please indicate the position for which you are applying.** For purposes of the COA, 'senior' is defined as age 60 or older. Also, applicants who may have knowledge of or expertise in communications, transportation, housing or health and wellness are encouraged to apply. **All members must be Montgomery County Residents.**

Serving as an advocate on behalf of older persons in the County, the COA advises and educates the County Executive, the County Council, various Montgomery County departments, and the State legislature about the concerns and needs of seniors. The effectiveness of COA advocacy has resulted in many programs and policies benefiting the County's older adult population. Members serve three-year terms without compensation, but are eligible for reimbursement for travel and dependent care for in-person meetings attended. Commissioners attend and actively participate in a monthly meeting of the COA, a quarterly meeting of one of the four COA committees, and planning and participation in other COA advocacy and outreach efforts, including an annual Stakeholders meeting, an annual State Legislators Breakfast, and meetings with individual County Councilmembers. When in-person meetings resume in the future, the Board will meet at various locations throughout the County.

Applicants of diverse backgrounds, professions, genders, geography, abilities, ethnicities, and ages are encouraged to apply. Members of County boards, committees and commissions may not serve on more than one such group at a time. Members must complete training on the Maryland Open Meetings Act and basic parliamentary procedure. The County Executive's appointments are subject to confirmation by the County Council. Erich Seeks Applicants for Animal Matters Hearing Board

County Executive Marc Elrich is seeking applicants to fill three vacancies on the Animal Matters Hearing Board. One vacancy is for a representative of licensed animal fanciers and two are for public members. One public incumbent is eligible to apply for reappointment.

The Animal Matters Hearing Board conducts hearings based on appeals and complaints related to incidents that occur in Montgomery County. Appeals arise from orders and decisions issued by the Director of the Animal Services Division as well as animal services officers. Complaints involve allegations of Chapter 5 (Animal Control) violations, such as animal nuisance complaints, animal cruelty, declaring a dog dangerous/potentially dangerous, violation of an adoption contract, or violation of a Board order. Complainants may also seek damages. The Board may award payment up to \$1000 plus the filing fee of \$25. The Board advises the County Executive and County Council on how to improve animal control laws, regulations, and programs, and proposes changes to the County's animal control facilities. There are seven members in the following categories: a representative of licensed animal fanciers, a representative of the County Humane Society, and five public members.

Members serve three-year terms without compensation, but are eligible for reimbursement for travel and dependent care for in-person meetings attended. The Board meets virtually by video- and teleconference an average of two to four meetings per month in the evenings to conduct hearings. When in-person meetings resume in the future, the Board will meet in Gaithersburg.

Members are required to file a public financial disclosure statement before County Executive appointment and annually thereafter.

Applicants of diverse backgrounds, professions, genders, geography, abilities, ethnicities, and ages are encouraged to apply. Members of County boards, committees and commissions may not serve on more than one such group at a time. Members must complete training on the Maryland Open Meetings Act and basic parliamentary procedure. The County Executive's appointments are subject to confirmation by the County Council. Applications will be forwarded to the Council for confirmation and may be made public as part of the confirmation process. The deadline for application is April 16, 2021. RACIAL EQUITY AND SOCIAL JUSTICE ADVISORY COMMITTEE

<u>Created --</u>	Established by County Council Bill 27-19, effective March 2, 2020. Montgomery County Code, Sec.27-83. Amended by Bill 44-20 adding two public members effective March 12, 2021.
<u>Purpose --</u>	The Committee must: (1) adopt rules and procedures as necessary to perform its functions; (2) keep a record of its activities and minutes of all meetings, which must be kept on file and open to the public during business hours upon request; (3) develop and distribute information about racial equity and social justice in the County; (4) promote educational activities that increase the understanding of racial equity and social justice in the County; (5) recommend coordinated strategies for reducing racial and social justice inequity in the County; (6) advise the Council, the Executive, and County agencies about racial equity and social justice in the County, and recommend policies, programs, legislation, or regulations necessary to reduce racial and social justice inequity; (7) meet periodically with the racial equity and social justice lead for each department and office; and (8) submit an annual report by December 1 of each year to the Executive and Council on the activities of the Committee.

Members must reflect a range of ethnicities, professional backgrounds, socioeconomic status, and places of origin to reflect the racial, economic, and linguistic diversity of the County's communities, with an emphasis on those most disproportionately impacted by inequities. Each member should have some experience in redressing disparate impacts based on race and social justice issues.
