<u>Created:</u>	Resolution 12-1032 (created 1993)
<u>Purpose:</u>	To advise the County Executive and the County Council of East County citizens' issues and concerns; advocate for regional priorities; and help facilitate solutions. The board serves as a liaison between the Eastern County community, and the County Executive, County Council, and County government departments by identifying community concerns and recommending possible solutions. It also advises the Director of the Eastern Montgomery Regional Services Center on transportation, economic development, housing, education, human services, environment, recreation, public safety, and other issues of importance to the area. The group reviews and comments on the County's capital and operating budgets and master plans; assists with strategies to tailor services to regional needs; and conducts workshops and forums, as well as acts on other ad hoc issues.
<u>Membership:</u>	Eighteen members, including one position reserved for a business representative. The membership represents a cross-section of citizens living or working in the Eastern region, including communities in the Fairland, White Oak and Cloverly vicinities. The area is roughly bound on the west by the Northwest Branch, on the north by Ednor Road, on the east by the Howard County and Prince George's County lines, and on the south by I-495.

Elinch Seeks Applicants for East County Citizens Advisory Board

County Executive Marc Elinch is seeking applicants to fill six vacancies on the East County Citizens Advisory Board. All the incumbents are eligible to apply for reappointment.

The 18-member Citizens Advisory Board serves as a liaison between the East County community, and the County Executive, County Council, and County government departments by identifying community concerns and recommending possible solutions. It also advises the Director of the Eastern Montgomery Regional Services Center on transportation, economic development, housing, education, human services, environment, recreation, public safety, and other issues of importance to the area. The group reviews and comments on the County's capital and operating budgets and master plans, assists with strategies to tailor services to regional needs, conducts workshops and forums, and acts on other ad hoc issues.

The advisory board is representative of more than 105,000 residents in eastern Montgomery County. This area includes the neighborhoods of Burtonsville, Fairland, White Oak, Cloverly, Hillandale, Briggs Chaney, Calverton, Spencerville, Ashton/Sandy Spring (part of) and Colesville. The service area is bordered on the north by Howard County, on the east by Prince George's County, on the south by Interstate 495 and on the west along Northwest Branch stream to Ednor Road.

Members serve three-year terms without compensation, but are eligible for travel and dependent care reimbursement for in-person meetings attended. The full Board currently meets virtually by video- and teleconference the third Wednesday evening of each month from 7:00 PM-9:00 PM except for July and August. There are two committees of the board that also meet monthly. When in-person meetings resume in the future, the Board will meet in the Eastern Montgomery Regional Services Center.

Applicants of diverse, backgrounds, professions, genders, geography, abilities, ethnicities, and ages are encouraged to apply. Members of County boards, committees and commissions may not serve on more than one such group at a time. Members must complete training on the Maryland Open Meetings Act and basic parliamentary procedure. The County Executive's appointments are subject to confirmation by the County Council. Applications will be forwarded to the Council for confirmation and may be made public as part of the confirmation process. The deadline for application is **June 2, 2021**.
