Background

- 1. On November 4, 2021, the County Council received Local Map Amendment (LMA) Application No. H-141.
- 2. White Oak Apartments, LLC requests rezoning of the property located at 2220 Broadbirch Drive, White Oak, Maryland, in the 5th Election District (Tax Account No. 05-03268832) from the CR-0.75, C-0.75, R-0.25, H-75 zone to the CRF-1.25, C-0.25, R-1.25, H-85 zone.
- 3. Under Section 7.2.1.F.4 of the Zoning Ordinance, the District Council must issue a resolution and opinion reflecting its decision on the application within 60 days after the Hearing Examiner's transmittal to the District Council, unless such time is extended by the District Council, or remand the application to the Hearing Examiner for further consideration.
- 4. Deadline for Council action on this local map amendment is January 3, 2021.
