DESCRIPTION/ISSUE

The Supplemental Appropriation to the Department of Health and Human Services (DHHS) of \$316,840 for the Extended IFSP Infants and Toddlers Grant will increase family engagement to improve the kindergarten school readiness outcomes of participating 3 to 5-year-old children. The funds will be used to educate early intervention providers about typical preschool development and age/child-appropriate activities to use with children and families, and help them develop and implement learning group interventions. A team of interventionists will serve as mentors and coaches to others who will educate parents about child development milestones, school readiness skills, and age-appropriate activities, and help develop and implement learning groups composed of typically developing preschoolers and preschoolers with developmental delays and disabilities.

SUMMARY OF KEY DISCUSSION POINTS

This increase is needed to improve the Kindergarten Readiness Assessment scores of the
preschoolers participating in the "Extended C" option of early intervention services and
ensure that children have the age-appropriate physical, pre-academic, and social-emotional
skills necessary to succeed in kindergarten and beyond.

I am recommending a Supplemental Appropriation to the FY23 Operating Budget of the Department of Health and Human Services (DHHS) in the amount of \$316,840 for the Extended IFSP Infants and Toddlers Grant. The grant aims to promote engagement between the Montgomery County Infants and Toddlers Program and the diverse families DHHS serves. The grant funds are from the Maryland State Department of Education. This Appropriation will be used to increase family engagement to improve the kindergarten school readiness outcomes of participating 3 to 5-year-old children.

This increase is needed to improve the Kindergarten Readiness Assessment scores of the preschoolers participating in the "Extended C" option of early intervention services. It will also ensure that children have the age-appropriate physical, pre-academic, and social-emotional skills necessary to succeed in kindergarten and beyond. The funds will be used to educate early intervention providers about typical preschool development and age/child-appropriate activities to use with children and families. A team of interventionists will serve as mentors and coaches to others who will educate parents about child development milestones, school readiness skills, and age-appropriate activities. Additionally, they will help develop and implement learning groups composed of typically developing preschoolers and preschoolers with developmental delays and disabilities.

I recommend this Supplemental Appropriation in the amount of \$316,840 and specify the source of funds as grant funds.

Background

- 1. Section 307 of the Montgomery County Charter provides that any supplemental appropriation shall be recommended by the County Executive who shall specify the source of funds to finance it. The Council shall hold a public hearing on each proposed supplemental appropriation after at least one week's notice. A supplemental appropriation that would comply with, avail the County of, or put into effect a grant or a Federal, State or County law or regulation, or one that is approved after January 1 of any fiscal year, requires an affirmative vote of five Councilmembers. A supplemental appropriation for any other purpose that is approved before January 1 of any fiscal year requires an affirmative vote of six Councilmembers. The Council may, in a single action, approve more than one supplemental appropriation. The Executive may disapprove or reduce a supplemental appropriation, and the Council may reapprove the appropriation, as if it were an item in the annual budget.
- 2. The County Executive has requested the following FY23 Operating Budget appropriation increase for the Department of Health and Human Services (DHHS):
