DESCRIPTION/ISSUE

The Supplemental Appropriation to the Department of Health and Human Services (DHHS) FY23 Operating Budget of \$517,608 will fund the Montgomery County, Maryland Crisis Hotline and Online Emotional Support text and chat services in the transition of the National Suicide Prevention Hotline Transition to the 988 Lifeline Call Center. The funds will support operational and administrative costs related to supplying Lifeline/988 hotline services, technology/phone equipment and services, and related expenses associated with electronic health records

I am recommending a supplemental appropriation to the FY23 Operating Budget of the Department of Health and Human Services in the amount of \$517,608 for the National Suicide Prevention Hotline Transition to the 988 Lifeline Call Center Grant. This appropriation will fund the Montgomery County, Maryland Crisis Hotline and Online Emotional Support text and chat services in their transition to 988.

This increase is needed to support EveryMind as it transitions to the 988 Lifeline Center. Through the Behavioral Health Administration, the State of Maryland provides these funds to help cover operational and administrative costs related to supplying Lifeline/988 hotline services, technology/phone equipment and services, and related expenses associated with electronic health records.

The non-competitive contract for EveryMind, Inc. is already included in Section G of Resolution 19-1285 that the Council approved for FY23.

Background

- 1. Section 307 of the Montgomery County Charter provides that any supplemental appropriation shall be recommended by the County Executive who shall specify the source of funds to finance it. The Council shall hold a public hearing on each proposed supplemental appropriation after at least one week's notice. A supplemental appropriation that would comply with, avail the County of, or put into effect a grant or a Federal, State or County law or regulation, or one that is approved after January 1 of any fiscal year, requires an affirmative vote of five Councilmembers. A supplemental appropriation for any other purpose that is approved before January 1 of any fiscal year requires an affirmative vote of six Councilmembers. The Council may, in a single action, approve more than one supplemental appropriation. The Executive may disapprove or reduce a supplemental appropriation, and the Council may reapprove the appropriation, as if it were an item in the annual budget.
- 2. The County Executive has requested the following FY23 Operating Budget appropriation increases for the Department of Health and Human Services:
