Commission on Health FY22 Annual Report

The Commission on Health (COH) respectfully submits its Fiscal Year (FY) 2022 Annual Report. Working with the County's leadership as well as the dedicated, professional, and conscientious staff of the Department of Health and Human Services (DHHS), the COH focused on several key public health issues over the past year. The COH also provided recommendations to county leadership and DHHS staff on improving county resident health and well-being.

In FY22, the COH had two priority areas related to communicable disease and school health. In addition, we articulated two principles to guide our work—our commitment to identifying, addressing, and correcting racial disparities in Montgomery County and to basing decisions on timely and reliable data.

Consistent with those priorities and goals, we submitted several letters to the County Executive and County Council, advocating for greater staff capacity to collect, compile, and analyze data; and advising on steps to reduce sexually transmitted infections in the County. We also focused on the County's ongoing response to the COVID-19 pandemic. We appreciate DHHS staff's robust and comprehensive efforts to slow transmission and to keep the COH informed. We were also deeply troubled to learn about the harassment faced by public health officials who were working to protect the public's health and wrote a letter in support of a state law to penalize that unacceptable behavior.

It has been an honor to serve as the chair of the COH during FY22. The Commission is comprised of 19 dedicated and very accomplished professionals who willingly volunteer their time and knowledge to leave a lasting positive effect on DHHS and Montgomery County Residents. The Commission also benefits from the expertise of ex-officio DHHS members and support from DHHS staff and liaisons from other commissions. The COH respectfully submits the attached FY22 Annual Report and looks forward to continued work and collaboration to improve public health and advise the County Council and County Executive.

Mission and Purpose

The primary mission of the Montgomery County Commission on Health (COH) is to advise the County Executive and the County Council on public health issues, programs, services and the allocation of funds devoted to public health needs and to monitor and assess the priorities of the Montgomery County Department of Health and Human Services (MCDHHS) in its efforts to address the health needs of residents in this County. The purpose of this report is to comply with the annual requirement that the COH provide the County Executive and the County Council with an update on the activities of the COH from July 2021 through June 2022.

County Code Enabling Legislation Sec. 24-24. Functions

To advise the County Executive and the County Council, the Commission must:

1. Periodically review available County public health programs, services, and facilities;
2. Comment on gaps, deficiencies, or duplication in County public health programs, services, and facilities;
3. Report each year to the County Executive on the performance of DHHS public health programs, actions needed to improve the programs, and the priorities within which the improvements should be made;
4. Comment on the proposed allocation of funds to County public health programs in accordance with the Department's priorities, considering the available financial resources and the need for health cost containment;
5. Advise on local public health planning needs;
6. Comment on the appropriateness of institutional health services proposed to be offered in the County and the metropolitan area by the private sector and nonprofit, state, or other public sector agencies;
7. Advise on the development of statewide criteria and standards for certificates of need and health planning, considering the regional impact when appropriate.
8. The Commission must report to and meet with the County Council, sitting as the County Board of Health, at least annually, on the programs and policies within its purview.

Structure

The Commission is comprised of 19 voting members with representation from consumers and providers of health services in the County. As dictated by County Code, the COH also has a representative from the Montgomery County Medical Society. In accordance with County Code the majority of the 19 commissioners were consumers with the balance being providers, including the Medical Society representative. The ex officio (non-voting) members of the COH include: the County Health Officer, currently filled by the Deputy Health Officer; the Montgomery County Public Schools liaison; and the County Council liaison. The COH continues to represent a diverse cross-section of Montgomery County residents.

Membership consisted of 19 members who were racially and ethnically diverse and vary in age, gender, geography and experience in health policy, public health, and the health care system.

The COH Chair and Vice Chair are elected by COH members and serve one-year terms. During FY22 Jessica Kronstadt was the Chair of the Commission and Crystal DeVance-Wilson was the Vice Chair.



Meetings

The COH meets at 6 p.m. on the third Thursday of the month (except in August). All meetings are open to the general public. Due to the COVID-19 pandemic, the COH met monthly via the virtual meeting platform Zoom during the entire 2022 fiscal year. Virtual meetings are planned for the beginning of FY23. However, when in person meetings resume they will take place at 401 Hungerford Drive, Rockville, MD 20850.

At a minimum, every member of the Commission is expected to either serve on one workgroup and, when possible, as a liaison to other health-related County boards, commissions, committees or minority health initiatives and programs.

With its broad perspective of public health, the COH recognizes the value of collaboration and communication with other health-related boards, commissions and committees. Many commissioners have an area of specialization, interest or constituency of public health and are therefore encouraged to serve as liaisons with other relevant health-related boards, commissions and committees (BCCs). Integral to this area of special interest is the constraint that all actions are in voice of the entire COH and not self-serving in any manner. Finally, members of the COH also served on committees that allowed the COH to conduct its business such as the membership, nominating and retreat planning committees. These committees require significant time and are in addition to the monthly scheduled meetings.

Commission on Health Workgroups Summary Reports

Governance

The Governance Workgroup focused on ensuring the Commission on Health is well-positioned to fulfill its functions. To this end, the workgroup requested and reviewed documentation from DHHS, including the strategic plan for Public Health Services. We also held a meeting with former ex-officer member and County Council Senior Legislative Analyst Linda McMillan and arranged for the new Council Senior Legislative Analyst Essie McGuire to present to the full Commission to ensure an understanding of the budget process and how the Commission could most effectively provide input into that process. Similarly, the County's DHHS Director, Dr. Raymond Crowel, was invited to speak at the June meeting to provide an overview of DHHS priorities to help inform the Commission's determination of priorities for the next fiscal year.

Racial Equity

During Fiscal Year 2022 the Commission on Health had a collective approach to helping eliminate racial disparities and improving outcomes for everyone living in Montgomery County. Commissioners analyzed policies, practices, systems, and structures with an intentional and continual practice of a racial equity framework. By prioritizing discussions and conversations around measurable changes in the lives of minorities and people of color, the Commission not only held itself accountable but ensured that everyone shared these understandings, and the Department treated the issue as a top priority.

Commission on Health Workgroups Summary Reports

School Health

The School Health workgroup of the Montgomery County Commission on Health focused on bringing new light to critical public health issues that have plagued our students. One area of particular concern was STI rates among the Montgomery County's teens and young adults. As a result, the COH requested additional data including an update from the Communicable Diseases program.

The Commission on Health received a presentation from Melvin Cauthen on "STIs in Montgomery County" in January 2022, highlighting the unacceptably high rates of STIs in student-age Montgomery County residents. Of particular concern is the disparity in STI rates, with BIPOC population rates nearly double that of white Montgomery County residents. In February 2022, the Commission on Health prepared and sent a letter to the Montgomery County Council advocating for additional interventions to reduce STI rates in Montgomery County president in February 2022.

The School Health workgroup is also represented at the School Health Council meeting where services and programming across the spectrum of physical and mental health in Montgomery County Public Schools are monitored. Full re-opening of health services and staffing of school health centers in MCPS, school closures due to the Covid-19 pandemic continue to be an important topic for key stakeholders. Other topics of considerations include nutrition/food services, vaccination clinics, environmental studies including drinking water safety, and availability of mental health services.

The School Health workgroup monitored the status of COVID-19 and its impact on health and education. Our efforts focused on reviewing access to vaccines and distribution to communities of most need. With an increased attention in the community on violence, the School Health workgroup reviewed current data and reports related to youth and community violence and met with County Council President Gabe Albornoz's staff that also indicated community violence as a priority. Both these issues are important for monitoring in the year ahead.
