#### **DESCRIPTION/ISSUE**

The County Executive requests Council approval of a Declaration of No Further Need (DNFN) to enter into a long-term 99-year lease with CASA de Maryland for County-owned office space at 14645 Rothgeb Drive in Rockville, Maryland.

The Property is improved with a commercial building which was formerly used as an animal shelter. CASA de Maryland occupies a portion of the building through a license agreement with the County. The rest of the building, which is in shell condition, is vacant.

CASA de Maryland currently has a contract for service with the County's Department of Health and Human Services to provide and operate a program of employment, training, and supportive services for low-income, multicultural residents at the subject building. The long-term lease of the vacant space is needed to allow CASA, Inc. to renovate this location as a workforce development and training center to provide employment and training services to low-income residents so they can access meaningful long-term employment. The rent charged to CASA is for a nominal sum and below fair market value, as CASA intends to operate a program in the County's public interest.

On October 11, 2022, the Council approved a CIP supplemental appropriation (Cost Sharing: MCG - CIP No. 720601), for DGS to enter into a new contract with CASA, Inc. in the amount of \$5,000,000 for the renovation of the space to suit CASA's program requirements, as well as an amendment to Section G, Fiscal Year 2023 Designation of Entities for Non-Competitive Contract Award Status listing CASA, Inc.

## The property transfer of this property complies with the requirements established under County Code 11B-45.01 Disposition of Real Property, including:

• This transaction is subject to the Property Disposition process as the lease of County-owned properties is in excess of two (2) years.

- The Executive transmitted to the Council the material terms on October 12, 2022.
- On October 20, 2022 Executive Order 212-22 was published in the County Register to give notice of the County's intent to proceed with disposition to CASA and that there was no further need for public use. A virtual public hearing was held on November 7, 2022.
- The Executive transmitted to the Council the Declaration of No Further Need on November 8, 2022.

SUBJECT: Approval of Disposition via Long-Term Lease of 14645 Rothgeb Drive, located in Rockville, Maryland, to CASA de Maryland

#### **Background**

- 1. Montgomery County Code §11B-45 requires the Council to approve a Declaration of No Further Need before the Executive can dispose of real property that has more than nominal value. Prior to seeking Council approval of a Declaration of No Further Need, the Executive must:
  - (a) submit all material terms of the proposed disposition and any appraisal the Executive relied on in setting the property's market value to the Council; and
  - (b) publish a declaration in the County Register and post a notice on the County website that the County has no further need for the property.

If the Council, by resolution, approves the Executive's Declaration of No Further Need, the Executive may dispose of the property for fair market value.

- 2. Montgomery County Code §11B-45 defines a disposition as "a sale, a lease or license for a term of 2 years or longer, or a lease or other document which includes an option to buy. If a license or lease for an initial term of less than 2 years is extended or renewed beyond 2 years, that extension or renewal is a disposition."
- 3. On October 12, 2022, the Executive transmitted the material terms of the proposed disposition. The Executive recommended entering into a long-term 99-year lease of County-owned office space at 14645 Rothgeb Drive, in Rockville Maryland, to CASA de Maryland ("CASA").
- 4. CASA de Maryland currently has a contract for service with the County's Department of Health and Human Services to provide and operate a program of employment, training, and supportive services for low-income, multicultural residents at the subject building. The long-term lease of the vacant space is needed to allow CASA to renovate this location as a workforce development and training center to provide employment and training services to low-income residents so they can access meaningful long-term employment.

- 5. On October 20, 2022 Executive Order 212-22 was published in the County Register to give notice of the County's intent to proceed with disposition to CASA and that there was no further need for public use.
- 6. The Council is scheduled for a public hearing and action on this recommended disposition on November 29, 2022.

#### **Action**

The County Council for Montgomery County, Maryland, approves the following action:

The Declaration of No Further Need for the Lease Agreement in Excess of two (2) Years of the County-owned office spaces located at 14645 Rothgeb Drive, Rockville Maryland, 20850 is approved and the property may be disposed of as described in the material terms provided to the Council on October 12, 2022, the memorandum dated November 8, 2022, and in Executive Order 212-22 as published in the County Register on October 20, 2022. The County Council waives the requirement that the disposition be a fair market value transaction.

On October 12, 2022, I transmitted material terms to Council and provided notice that I intend to dispose through long-term lease County-owned property located at 14645 Rothgeb Drive, Rockville, Maryland 20850 ("Property") to CASA de Maryland.

As required under Section 11B-45 of the Montgomery County Code, an Executive Order must be issued declaring that the County-owned site is no longer needed for public use. Attached please find Executive Order 212-22 which was published in the *County Register* on October 20, 2022 to give notice of my intent to proceed with the 99-year lease to CASA de Maryland for a nominal sum. The County Council may waive the requirement that the Subject Property be disposed of at full market value under section 11B-45 of the County Code.

The Property is improved with a commercial building which was formerly used as an animal shelter. CASA de Maryland occupies a portion of the building. The rest of the building, which is in shell condition, is vacant.

CASA de Maryland currently has a contract for service with the County's Department of Health and Human Services to provide and operate a program of employment, training, and supportive services for low-income, multicultural residents at the subject building. #### Recitals

WHEREAS, the County owns approximately 3.8 acres of property at 14645 Rothgeb Drive, Rockville, described in the Deed recorded among the Land Records of Montgomery County at Book 4384, page 574 and ("the Property"); and

WHEREAS, the Property is improved with a commercial building which was formerly used as an animal shelter; and

WHEREAS, the County intends to enter a 99-year lease for a nominal sum with CASA de Maryland which currently has a contract for service with the County's Department of Health and Human Services to provide and operate a program of employment, training and supportive services for low income, multi-cultural residents at the subject building; and

WHEREAS, CASA de Maryland currently occupies a portion of the building pursuant to a License Agreement with the County to provide the above described services per the contract for services. The rest of the building, which is in shell condition, is vacant; and

WHEREAS, the Property must go through disposition to allow for the long-term 99-year lease; and

WHEREAS, the County Executive has completed the Preliminary Reuse Review and Reuse Analysis; and

WHEREAS, the material terms of the sale of the Property are as stated above; and

WHEREAS, under Section 11B-45 of the County Code, the County Council may waive the requirement that the Property be disposed of at full market value; and

WHEREAS, in accordance with the provisions of Montgomery County Code Section 11B-45 and COMCOR 11B.45.01.08, Disposition of Real Property, the County Executive must issue an Executive Order declaring that County owned or controlled land is no longer needed for County use.

#### Background

- 1. Section 307 of the Montgomery County Charter provides that any supplemental appropriation shall be recommended by the County Executive who shall specify the source of funds to finance it. The Council shall hold a public hearing on each proposed supplemental appropriation after at least one week's notice. A supplemental appropriation that would comply with, avail the County of, or put into effect a grant or a Federal, State or County law or regulation, or one that is approved after January 1 of any fiscal year, requires an affirmative vote of five Councilmembers. A supplemental appropriation for any other purpose that is approved before January 1 of any fiscal year requires an affirmative vote of six Councilmembers. The Council may, in a single action, approve more than one supplemental appropriation. The Executive may disapprove or reduce a supplemental appropriation, and the Council may reapprove the appropriation, as if it were an item in the annual budget.
- 2. Section 302 of the Montgomery County Charter provides that the Council may amend an approved capital improvements program at any time by an affirmative vote of no fewer than six members of the Council.

- 4. The County will lease the premises at 14645 Rothgeb Drive, Rockville, MD to CASA, Inc. for the purpose of developing a workforce development and training center. This increase is to allow CASA, Inc. to renovate this location as a workforce development and training center to provide employment and training services to low-income residents so they can access long-term meaningful employment. The recommended amendment is consistent with the criteria for amendment to the CIP because it presents a significant opportunity for enhancing workforce development, training, and small business support and leverages private funds.
- 5. The County Executive recommends an amendment to the FY23-28 Capital Improvements Program and a supplemental appropriation in the amount of \$5,000,000 for Cost Sharing: MCG (No. 720601), and specifies that the source of funds will be Current Revenue: General.
- 6. Section 11B-14 (a) (4) of the Montgomery County Code states that a contract may be awarded without competition if the Chief Administrative Officer makes a written determination that the contract award serves a public purpose and the proposed contractor has been identified in a grant or appropriation resolution approved by the Council.
